Request for Extension of Special Permits: ESS Sudbury Athletic Academy LLC – 141 Boston Post Road

Case Nos. 00-32 & 00-33

(Stephen M. Richmond abstained from this item due to a conflict of interest)

Attorney Joshua Fox was present to request an extension for the ESS Sudbury Athletic Academy Special LLC Special Permits 00-32 and 00-33. He explained that the permits granted by the Board of Appeals in January 2001 were appealed and finally resolved in September 2002.

Since that time he said ESS was unable to move forward because of financing and other considerations. In addition, as a result of the settlement and the conditions placed on the project by other Town Boards, ESS has not been able to move from the plan drafting phase into the construction phase. It is hoped that this will occur within the next several months.

As a result, ESS is requesting a one-year extension of the special permits to September 17, 2002.

Mr. Delaney indicated the Board is familiar with this project and, given the circumstances, the request for extension is reasonable. The other Board members concurred.

MOTION: "To grant ESS Sudbury Athletic Academy LLC a one (1) year extension of Special Permits 00-32 and 00-33, said permits to lapse on September 17, 2003 if construction has not begun by such date."
