**8:00 PM: John Duran III, P.E.** – presented a proposal septic system design for a new residence at 155 Landham Road. An existing greenhouse facility with a cesspool will be removed. A variance was requested for a pump system due to excessive fill and grading required around the dwelling if a gravity flow system were installed. The feasibility of a gravity flow system is further affected the wetlands on the parcel. The Board voted to approve the variance requested with a 1500 gallon pump chamber and dual pumps.

The Board reviewed a proposed pressure dosed septic system for a comprehensive housing project with sixteen two bedroom units on Carriage Lane off Boston Post Road. The Health Director explained that project is required to meet Title V but not Board of Health local regulations, however, Sullivan, Connors Engineering has designed a system that meets the local regulation requiring 150 square feet of leaching trench sidewall per bedroom.

The Board reviewed and approved a FY 03' contract with Parmenter VNA and Community Care.
