HOUSEHOLD HAZARDOUS WASTE- This program has been slated from the current BOH budget. Bob reported that residents in Town expressed their concern with this

decision. Household wastes have been found on the sides of some Sudbury streets. Talk centered around the possibility of amending this year's budget to \$16,000 to accommodate for a Household Hazardous Waste Day here in Sudbury. It was decided that this issue would be brought up at Town Meeting in April.

APPLE ORCHARD- Discussion was held about the possibility of testing a well near this property. A letter has been received from David Aronson, Brimstone Lane, expressing concern about a possible connection between pass chemical spraying at a former apple orchard and cases of Alzheimer's disease. It was agreed that the BOH would take on the responsibility of testing one of the wells on the property. If the testing comes back as positive for finding something, then a decision would have to be made about testing the other wells near the property.

TOWN MEETING ARTICLE # 30- Discussion continued about why the Health Director should not be under the Town Manager's Control. Board members formulated arguments that can be used against the warrant article at Town Meeting in April.
