8:00 appointment: Bob McDonald- outside wood boilers

Mr. McDonald met with the Board to make a presentation on the use of outside wood boilers in the Town of Sudbury. Mr. McDonald's presentation consisted of the importance of discontinuing outside wood boiler use within the Town of Sudbury due to health effects. Mr. McDonald's presented facts from the EPA, DEP and other agencies that state the use of outside wood boilers is detrimental to a person's health based on the amount of particulates that are released into the air from the burning wood(s) that are used. Mr. McDonald also presented information on local, neighboring towns that have banned usage of these wood boilersincluding the towns of Tisbury and Westborough, MA. Mr. McDonald also referenced a Maryland ordinance that charges a \$25, 000 fine for any resident using an outside wood boiler as well as the State of Washington's ban on their usage. Mr. McNamara, Board Chairman stated that Mr. McDonald's concerns would be taken into account by the Board and that the Board would conduct their own independent research into the matter.

Dr. Geitz, Board member supported Mr. McNamara's stance that the Board would most definitely conduct their own independent research as well as stating that the Board would also take the time to review data that Mr. McDonald provided.

Dr. Kern, Board member asked Mr. McDonald if he would consider going through Town Meeting to get a by-law passed. Mr. McDonald said that he had spoke to Town Counsel about this and was told that even if a by-law were passed through Town Meeting, existing outdoor wood boilers would be grandfathered in for future use.

The Health Director stated that other wood boilers being used in the Town of Sudbury would need to be examined and identified. Mr. McDonald stated that he has retained an environmental consultant and an attorney.

In closing, Mr. McDonald said that if the Board was not going to take his initiative to ban outdoor wood boilers seriously, he was not going to "go away" and would be "back again and again" with "more people" and then with "more and more people" until the Board decided to take this issue seriously.

8:30 appointment: Elizabeth Wood- Massage Therapy Applicant

Ms. Wood came before the Board to apply for a Massage Therapy license to practice at the Elizabeth Grady Salon located at 423 Boston Post Road, Sudbury. It was determined by the Board that Ms. Wood met all of the Town's massage therapy requirements. Dr. Kern made a motion to grant Ms. Wood a license to practice massage therapy at Elizabeth Grady Salon, Sudbury through the 2007 calendar year. Motion was granted.

Miscellaneous Business:

MRC Executive Meeting- Dr. Geitz spoke about inviting individuals who have volunteered to serve on the executive committee for the Sudbury MRC be invited to the next Board of Health meeting on October 12th.

A Title V Covenant and Easement document for Sudbury Meadows shared system at North Road has been submitted to the Board of Health. Motion was made by the Health Director to accept the document subject to review by Town Counsel.

Hazardous Waste Collection Day- HWCD is scheduled for October 14, 2006 from 9:00a.m.-1:00p.m., and is to be held at the Curtis Middle School Parking Lot at 22 Pratts Mill Road, Sudbury. The Health Director spoke about needing 2 police officers to work a detail for that day to logistically handle patrons overhaul—the Board approved having 2 police officers on site.
