### **FY' 2011 Budget:**

- A constrained FY '2011 Budget was requested.
- 1-5% decrease from the FY' 2010 budget line item
- Decreased Mental Health line item. Requesting funds from the Cherri Ann Cavanaugh Fund to compensate for decrease in Mental Health funds.

- Nursing Services= level-funded
- Rabies Control= level-funded
- Animal Inspector= level-funded
- Senior Outreach= there is a need to cut back on this line item due to the constrained FY '20100 budget
- General Expense= There is a change in this line item. The DPW will now be billing out individual department's for gas billing

# FY' 2011 Fixed Growth Budget:

• 3% ^ in salaries/expenses

What this would cover:

- (1) 30% to Mosquito Control Services
- (2) 3% for vacation coverage for Social Worker's
- (3) 3% increase for Nursing Services
