4:00pm: Lisa Egelston: Proposed Revision to In-Ground Irrigation Bylaw

- Ms. Egelston, Member of the Water Commission came in to discuss changes to the current BOH In-Ground Irrigation Bylaw:
- As the Bylaw states now- residents who have private irrigation wells are exempt from rules and regulations when drought conditions occur
- Water is restricted based on:
 1. Water State Permitting
 2. Conservation Measures Included
 3. Previous year consumption

3. Pantry-Brook area

- There is a perception that mosquito spraying using pesticides is detrimental to human and certain animal species- this is not the case- mosquito spraying using these materials does not cause problem(s) to human or bee species- spraying only occurs near high-populations of mosquito breeding activity as well as during crises- i.e.: EEE.

Health Director's Report December 2016

Food Inspections- DiVinci's (Friendly's site) is planning a January opening. Pre-opening inspections are being conducted on a routine basis.

A foodborne illness complaint was investigated. A Framingham resident reported food purchase at a local establishment on Christmas Day made her and her family ill. An inspection was conducted and no violations were observed.

Septic Inspections- There were 4 soil evaluations and 14 installation/repair inspections.

Budget- Budget planning is still in progress. Potential cuts to the mosquito control budget are being proposed

Nuisance- Sewage breakout at Shaw's Plaza was reported through a complaint from DEP. An investigation revealed that a faulty pump caused sewage to overflow the pump chamber onto a driveway, threatening a local wetland. An investigation revealed the overflow was minimal. The pump was repaired and lime was placed over the driveway. The spill was contained due to ice buildup on the side of the roadway. Incident was referred to the Conservation Commission.

Housing- A housing inspection was conducted at 379 Concord Road for the purpose of satisfying a requirement for the Massachusetts rental voucher program.

Beavers - Problematic beavers continue to build dams throughout town compromising culverts, roadways, septic systems, and personal property. Monitoring and control is on-going with the DPW.
