The statutory requirements as to notice having been complied with, the meeting was convened at 7:17 p.m. in the Town Clerk's Office, 322 Concord Road, Sudbury.

Chairman O'Brien opened the meeting at 7:17 p.m. and announced the close of the regular meeting and would reconvene following Executive Session.

It was on roll call unanimously

VOTED: To enter into Executive Session for the purpose of discussing collective bargaining matters related to successor contracts strategy for the Civilian Dispatchers and the Firefighters wherein strategy discussion with respect to collective bargaining in an open session may have a detrimental effect on the bargaining position of the public body.

Collective Bargaining Agreement – Sudbury Civilian Dispatchers

Town Manager Maureen Valente and Asst. Town Mgr./HR Director reviewed the Memorandum of Agreement (MOA) with the Sudbury Civilian Dispatchers Teamsters Local 25, dated March 27, 2013. The monetary items in the Successor Contract are the same as had been previously discussed with the Board of Selectmen (BOS).

Selectman Drobinski moved to approve the MOA between the Town of Sudbury and the Sudbury Teamster Local Union No. 25 on behalf of the Town of Sudbury Civilian Dispatchers, dated March 27, 2013. Chairman O'Brien seconded the motion.

Collective Bargaining Agreement – Sudbury Permanent Fire-Fighters Assoc.

Town Manager Maureen Valente and Asst. Town Mgr./HR Director then reviewed the Memorandums of Agreement with the Sudbury Permanent Fire-Fighters Association, Local 2023, dated March 27, 2013. The monetary items in the Successor Contract are the same as had been previously discussed with the BOS. They further stated that the items in the Firefighters ALS-Combined Dispatch MOA were in line with all items previously discussed and approved by the Board.

Chairman O'Brien moved to approve the Successor MOA and the ALS-Combined Dispatch MOA between the Town of Sudbury and the Sudbury Permanent Fire-Fighters Association, Local 2023, dated March 27, 2013. Selectman Drobinski seconded the motion.

All voted in favor of the motion: Chairman Lawrence W. O'Brien, aye; and Selectman John C. Drobinski, aye.
