Dear Board Members:

As Co chair of the Permanent Building Committee, we would strongly recommend that the supplemental sum of \$ 280,800 for the Sudbury Police Headquarters be approved at the September 4th Special Town Meeting based upon the following:

Historical

Prior to the March 2014 Election, the cost projections for the Police Headquarters project was established at \$ 7.8 million reduced by the \$ 627,000 funded by the 2013 authorization of Town Meeting reflecting \$ 7.2 million at the Ballot.

Prior to the May, 2014 Annual Town Meeting, the Permanent Building Committee was informed that the construction market was escalating beyond our expectation and engaged a second estimator to assure that appropriate funds would be requested. This estimate reflected that an additional \$ 700 K would be required.

Presentations during Town Meeting discussed the issue and resulted in the approval of \$7.2 million with the understanding that the PBC would solicit bids for the project and schedule a Special Town Meeting for supplemental funds if necessary.

Bid Results

On August 20th, four construction bids were received ranging from \$ 5,993,000 to \$ 6,985,000 for the Base Project. With the addition of the Planning Board required landscaping and the recommended covered canopy, the lowest acceptable construction cost is \$ 6,141,000. The attached spreadsheet updated to August 28th, depicts the Construction Costs, Soft Costs, FF& E, Contingency and Bonding Costs based upon the lowest responsible bidder.

Recomendations

Based upon a total Project Cost of \$8,107,800, ATM 2013 funding of \$627,000 plus the \$7.2 million authorized at ATM 2014, an additional \$280,800 is requested during at the September 4^{th} Special Town Meeting.

It is further recommended that the additional funds be obtained within the levy rather than bonding. Should the ballot question fail, the landscaping and covered canopy could not be awarded at this time, some of the Police Station's FF& E would be curtailed and the project contingency would be reduced. Since these items are strongly recommended, funding would be requested at a subsequent Town Meeting at increased costs.

We will be pleased to discuss any issues during the Selectmen's Meeting on September 3rd and look forward to your favorable consideration

Debt Financing Addendum:

Based on the latest information provided by the PBC, the remaining estimated cost to complete the Police Station is \$280,800. I have been asked to provide the following information as an estimate for the entire project using the same assumptions for an exempt debt issue, for 20 years. Please note that year 1 of debt service for this bond issue has still to be determined. However, for purposes of this STM, the start date of debt service repayment is <u>not</u> an issue or a matter that needs to be discussed. Actual appropriation(s) for debt service payments takes place on an annual basis as part of the regular operating budget article. Please also note that the amount of permanent borrowing is strictly dependent on actual costs to complete the project. Any unused borrowing authorization(s) can and will be rescinded at Town Meeting at a later date. Furthermore, the Town is strictly prohibited from borrowing more than what has been authorized at Town Meeting (and at an election, if applicable).



Commonwealth of Massachusetts Middlesex, ss.

To the Constable of the Town of Sudbury:

GREETINGS: In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Sudbury, qualified to vote in Town affairs, to meet at the Lincoln-Sudbury Regional High School Auditorium in said Town on Thursday, September 4, 2014, at 7:30 o'clock in the evening, then and there to act on the following articles:

ARTICLE 1. CONSTRUCTION OF POLICE HEADQUARTERS - SUPPLEMENTARY PROJECT FUNDING

To see what sum the Town will vote to raise and appropriate, or appropriate from available funds, for the purpose of augmenting the appropriation for constructing a new Police Department Headquarters and appurtenant structures on Town-owned land adjacent to the existing Fire Headquarters, as voted under Article 14 of the 2014 Annual Town Meeting and approved previously in the debt exclusion question voted at the 2014 Annual Town Election, said sum to be expended under the direction of the Permanent Building Committee; and to determine whether said sum shall be raised by borrowing or otherwise; or act on anything relative thereto.

Submitted by the Board of Selectmen.

(Two-thirds vote required, if borrowed)

PERMANENT BUILDING COMMITTEE REPORT: Additional funding is requested for the construction of a new Police Department Headquarters, the amount of which will be determined by the bid of the lowest eligible General Contractor in late August, 2014. The limits set forth in the Proposition 2 ½ Ballot Question approved at the March 31, 2014 Annual Town Election precluded the Town from raising additional funds under Article 14 of the May Annual Town Meeting although an increase of \$700,000 was desired based on a professional estimate received in the intervening months.

As background, the Summary section of the Election Warrant for the March 31, 2014 Annual Town Election noted that, at the time of warrant signing, the total project cost had not been finalized and an estimated total construction phase cost was provided in order to give an estimated impact on the tax rate for the construction, construction administration and furnishings of the project.

Prior to the May Town Meeting, a new professional estimate based on more complete technical specifications and drawings indicated a significant <u>construction</u> cost increase consistent with the apparent improvement in the construction environment. Town Meeting, however, was limited to voting the sum of \$7.2 Million being precluded by the limitations of the Ballot Question from voting the higher \$7.9 Million desired to allow for the higher bidding climate. Accordingly, it was decided at that time to publicly bid the project construction and request additional construction funding, if any, once the actual bids were received at a subsequent Special Town Meeting. If the final funding request based on the bid is, in fact, an additional \$700,000, the maximum

added to the tax rate above would be \$8 at the highest point based on \$.01 per \$1,000 assessed value on the average home value. Permanent borrowing will be based on the actual project cost.

BOARD OF SELECTMEN POSITION: The Board will report at the Special Town Meeting.

FINANCE COMMITTEE REPORT: The Finance Committee will report at the Special Town Meeting.

ARTICLE 2. RESOLUTION (Non-binding): RAIL TRAIL FROM WAYLAND TOWN LINE TO HUDSON TOWN LINE

To see if the Town will vote to advise the Board of Selectmen to create a recreational rail trail more or less in the rail right-of-way known as the Mass Central Rail Trail (MCRT).

SUBMITTED BY PETITION.

(Majority vote required.)

PETITIONERS' REPORT: <u>Background</u> The Mass Central Rail Trail is a proposed multi-use recreational trail along the former rail right-of-way (ROW) of the Massachusetts Central Railroad, which runs 104 miles from Boston to Northampton. The abandoned corridor has been owned by the MBTA for decades. The MBTA recently leased this corridor to the MA Department of Conservation and Recreation (DCR) for 99 years for the explicit purpose of converting the ROW to a rail trail. The DCR is actively working with communities in a 26 mile stretch from Waltham to Berlin known as the Wayside Branch to convert the ROW to a rail trail. The Sudbury portion of the trail is roughly 4.6 miles long from the Wayland town line to the Hudson town line. The ROW runs from east to west, crossing under Landham Road, and at grade at Boston Post Rd, Union Ave, Horse Pond Rd, Peakham Rd and Dutton Rd. We are asking the Board of Selectmen to work actively with DCR to develop this trail in Sudbury.

BOARD OF SELECTMEN POSITION: The Board of Selectmen will report at the Special Town Meeting.

FINANCE COMMITTEE REPORT: The Finance Committee will report at the Special Town Meeting.

ARTICLE 3. RESOLUTION (Non-binding): MA CENTRAIL RAIL TRAIL (MCRT) FROM DUTTON ROAD TO UNION AVENUE

To see if the Town will vote to advise the Board of Selectmen to move forward with the design and construction of a greenway style rail trail in the rail right-of-way known as the Mass Central Rail Trail (MCRT) between Dutton Road and Union Avenue as the first phase of the development of the MCRT in Sudbury.

SUBMITTED BY PETITION.

(Majority vote required.)

PETITIONERS' REPORT: <u>Background</u> The Town of Sudbury, MA Department of Conservation and Recreation and Sudbury Greenways have met in July 2014 to discuss a phased approach to converting the rail right-of-way (ROW) to a greenway style rail trail. The DCR has stated they would allow for a phased development of the trail in Sudbury. The stretch from Dutton Rd to Union Ave has been identified as a being the lowest cost stretch to convert having no bridges, no high volume road crossings, and less wetlands proximity than other parts of the trail. This stretch connects many neighborhoods and offers access into the Route 20/Union Ave commercial area. The trail would meet all of the DCR's conversion requirements

(including but not limited to: 10 feet in width, having a rolled stone dust finish surface, ADA compliant access points, 2 foot flexible shoulders, and safe road crossings). We are asking the Board of Selectmen to develop a greenway style rail trail along this stretch of ROW as part of a phased trail development in Sudbury. Greenway style rail trail development is town driven and would be permitted and constructed under Sudbury Town Bylaws.

BOARD OF SELECTMEN POSITION: The Board of Selectmen will report at the Special Town Meeting.

FINANCE COMMITTEE REPORT: The Finance Committee will report at the Special Town Meeting.

TOWN OF SUDBURY SPECIAL TOWN ELECTION WARRANT

Commonwealth of Massachusetts Middlesex, ss.

To the Constable of the Town of Sudbury:

GREETINGS: In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Sudbury, qualified to vote in Town Elections, that voters residing in Precincts 1, 1A, 2 and 5 should meet at the Fairbank Community Center and voters residing in Precincts 3 and 4 should meet at the Town Hall in said Town on Tuesday, September 9, 2014, at seven o'clock in the forenoon; then and there to vote on the following ballot question:

BALLOT QUESTION

Shall the Town of Sudbury be allowed to exempt from the provisions of proposition two and one-half, so-called, the amounts required to pay for the bond issued in order to provide additional funding to construct a new Police Department Headquarters and appurtenant structures on Town-owned land adjacent to the existing Fire Headquarters including borrowing costs and expenses?

SUMMARY: The 2014 September Special Town Meeting will include an article for the expenditure of supplementary funds not to exceed Seven Hundred Thousand and no/100 Dollars (\$700,000.00) for construction of the new Police Department Headquarters approved at the 2014 Annual Town Meeting.

This ballot question seeks to exclude from the Proposition 2½ levy limit the principal and interest to pay for the additional funds, which may be necessary to pay for the project. The project has been advertised for bidding. Professional estimators have advised that the construction market is in an upswing concluding that the bids received will be higher than anticipated. The bids will be received on or about August 20, 2014, after this warrant is printed but before the Town Meeting. If some or all of the funds are not necessary they will not be appropriated at the Special Town Meeting. The bids will be the determining factor for the amount of additional funding to be requested at the Special Town Meeting. If this debt exclusion receives approval via this ballot and Town Meeting subsequently appropriates all or some of the \$700,000.00, permanent bonding will be obtained at the conclusion of the project based on actual expenditures.

If all of the supplementary funds are appropriated at the Special Town Meeting the estimated impact on the tax rate of this component (\$700,000.00) is: \$0.01 per \$1,000 assessed value at the highest point of the bonding period (based upon a 20-year bond at 2.5%). For example, the tax impact on the 2014 average home value of \$640,270 is estimated at \$8 in the first year of debt service, and would decline each year during the bonding period.

A "yes" vote on this question will authorize the Town to exclude from the levy limit the debt required for the amount of the supplementary funds needed for construction of a new Police Headquarters facility, with all associated work connected thereto, subject to appropriation by Town Meeting; and a "no" vote will mean that debt incurred for additional funding, if any, will not be exempted from the Proposition 2 ½ tax levy limit.

The prior approval of the ballot question at the 2014 Annual Election is not affected by this vote and cannot be rescinded.

ARGUMENT FOR PASSAGE: The 2014 Annual Town Meeting approved replacing the antiquated Boston Post Road Police Station and constructing a Police Headquarters on Town owned land adjacent to the Hudson Road Fire Station where training and other resources can be shared. They voted \$7,200,000 knowing this amount was based upon an earlier estimate of construction costs.

As the economy has improved, we have entered into a period of quickly escalating costs in the construction industry. Town Meeting was advised during the presentation that updated cost estimates for the project pointed to the need for up to \$700,000 more to build the currently designed project given these market changes.

It was decided to obtain bids during the summer in order to establish the total project cost based on current market conditions with a fall Special Town Meeting and Election called for additional funding as may be necessary. With these last funds secured, Sudbury can at last move forward with this important project.

Sudbury's Permanent Building Committee, which has overseen the construction and/or renovation of all School and Town buildings over the past several decades – on time and under budget - will work with Sudbury's Facility Director and Police Chief even in this time of rapidly rising construction costs, to bring to Sudbury an outstanding new Police Headquarters residents can be proud of and continue the tradition of excellent police services.

ARGUMENT IN OPPOSITION: For years, Sudbury voters have discussed addressing our aging police station, which is currently located in the business district on frequently traveled Route 20. In March 2014, Sudbury voters approved funding a police station for \$7,200,000, and even before the groundbreaking, we are asked for another \$700,000.

The current costs include a contingency of 6.6%, which is far below industry. Sudbury leadership has failed to manage past projects, recently acknowledging a 14.7% overrun to the town center project.

The proposed facility is 14,540 sq. ft., compared to the current of 6400 sq. ft. The proposed facility is more than double the size the existing yet will house no more than 8 or 9 employees at any time. There are 4 holding cells yet only 1 person taken into custody every 2 days; most persons are released within a couple of hours.

Land improvements represent approximately 12% of the proposal. This seems excessive and taxpayer money is better spent locating the police department closer to the most frequently traveled and business district.

Sudbury voters support public safety and its Police Department. However, Sudbury does not need to construct this massive facility which also relocates our Police Department to a quiet residential neighborhood that is off the beaten path of the main traffic path and business district in town.

Sudbury voters already approved \$7,200,000 to construct a new police station. Sudbury leadership needs to construct a facility within this amount, reducing costs and/or location.
