VOTED: To approve and not release the May 26, 2020 Executive Session minutes, as edited.

June 17, 2020 Executive Session Minutes

Selectman Carty motioned to approve and not release the June 17, 2020 Executive Session Minutes. Vice-Chair Roberts seconded the motion.

It was on motion, 5-0; Carty-aye, Russo-aye, Roberts-aye, Schineller-aye, Dretler-aye

VOTED: To approve and not release the June 17, 2020 Executive Session Minutes.

Chairman Dretler asked Board members about releasing and redacting Executive Session minutes which included the LSRHS Agreement topic, and then continue any further LSRHS discussions in Open Session.

Vice-Chairman Roberts indicated she was not sure about bringing the LSRHS Agreement topic to Open Session at this time.

Selectman Russo confirmed that he reviewed the Executive Session minutes which dealt with the LSRHS Agreement topic, and agreed with addressing LSRHS Agreement aspects in Open Session.

Vice-Chairman Roberts requested that an additional LSRHS Agreement discussion in Executive Session take place to further clarify related aspects/possible negotiations with LSRHS.

Selectman Schineller stated that he was fine with continuing LSRHS Agreement conversation in Open Session, but was agreeable to conducting another robust discussion in Executive Session.

Selectman Carty maintained the LSRHS Agreement was a high priority Selectmen's Goal, and the Board had conducted three very comprehensive Executive Session meetings regarding the topic. He stated Board members indicated their preference for conducting LSRHS Agreement discussion in Open Session, going forward. Selectman Carty acknowledged that the Board could regroup and continue related discussion with an additional Executive Session, which would further detain related communications/action by a month.

Selectman Schineller stated that he wanted to advance the goal without compromising Board negotiations.

Vice-Chairman Roberts expressed her hesitancy regarding release and redacting of mentioned Executive Session Minutes and confirmed that she would be available to participate in another Executive Session meeting within three days.

Selectman Carty motioned to release and redact all LSRHS Agreement aspects from the 8/4/20, 8/11/20 and 9/8/20 Executive Session Minutes. Selectman Schineller seconded the motion.

Vote to close executive session and resume open session

Chairman Dretler motioned to close executive session and resume open session. Selectman Russo seconded the motion.
