1. Boston Edison Hearing

Blackmere Road: Twelve (12) poles, easterly of approximately 145 feet east of Landham Road. No new poles to be installed. The petition requested location of poles heretofore maintained in a private way. The Selectmen moved, seconded and unanimously voted to approve the petition of the Boston Edison and New England Tel. & Tel. Co. as described, having been informed by the Power & Light Com. that it had no objection and none of the abutters present voiced objection.

Mossman Road: One (1) hip guy and anchor. Anchor<sup>g</sup> guy to be installed to sustain and protect pole on Mossman Road. The Selectmen moved, seconded and unanimously voted to approve this installation having been notified by the Power & Light Com. that it had no objection to this installation.

2. Minutes

The Selectmen moved, seconded and unanimously voted to approve the minutes of the meeting of January 9, 1964.

3. Warrants

The Selectmen signed payroll and accounts payable warrants.

4. Site Plan

The Selectmen reviewed the site plan #T-1, dated 12/20/63, for a proposed office and commercial building submitted by Lawrence W. Tighe, and submitted this site plan to the Planning Board for its recommendations.

5. Extension of Beverage Service - Wayside Inn

It was moved, seconded and unanimously approved to grant permission to the Wayside Inn to extend the hours of beverage service on the night of Friday, January 24, 1964, to Saturday, January 25, 1964, until 1:00 A.M.

6. Appointment to Conservation Commission

The Selectmen moved, seconded and unanimously voted to appoint Mrs. Evelyn P. Morrison, 86 Stone Road, to the Conservation Commission having received a recommendation from the Sudbury Conservation Commission.

7. Parking - Fire Station

The Selectmen  $\frac{1}{2}$  moved, seconded and unanimously voted to restrict parking in the driveway in front of the Center Fire Station having received a report from the Fire Chief stating the problem which has arisen because of the uncontrolled parking. Parking in the driveway is to be restricted to the Fire Chief's vehicle and to vehicles used by the men in answering a fire call.

8. Stop Sign - Intersection of Union Avenue and Concord Road

The Selectmen moved, seconded and unanimously voted to request that the Police Chief undertake the necessary steps to have stop signs erected at the intersection of Union Avenue and Concord Road.

9. Dog Hearing - Boxer, 195 Horse Pond Road

After hearing the evidence, the Selectmen postponed the final decision on the hearing until further information could be obtained from the Dog Officer, Harry Rice. A decision will be forthcoming on Monday, January 20, 1964.

Minutes of Hearing on Boxer dog, 195 Horse Pond Road

In attendance: Mr. Norman Sjostedt, owner of dog; Mr. ~~W~~ Frederick J. Eisner, 220 Horse Pond Road; Mr. George A. Fuller, 185 Horse Pond Road; Mr. Elbert W. Clark, 200 Horse Pond Road; Mr. Edward A. Sherman, complaintant; Mr. Harry C. Rice, Dog Officer.

Mr. Edward F. Moynihan read the letters of complaint and letters from the Selectmen requesting that Mr. Sjostedt restrain his dog.

Mr. Sjostedt stated that his dog had never done harm to anyone, that there are literally dozens of children in the neighborhood, and that the dog is friendly to all. Messrs. Eisner, Fuller and Clark all supported this statement of Mr. Sjostedt, citing experiences of their own children and dogs as examples. It was Mr. Sjostedt's contention that Mr. Sherman has female and male poodles with puppies, which would naturally attract dogs and, where his dog was also a female, that some difficulties could be expected.

Mr. Sherman stated that, regardless of the boxer dog's behavior with others, the fact remains that the dog had ~~at one time bitten his daughter and that, only recently, had chased his niece from~~ at one time, bitten his daughter and that, only recently, had chased his niece from ~~the~~ Mr. Sherman's driveway back into the house.

Mr. Rice stated that the Sjostedt's boxer had, in fact, been quarantined on May 27, 1963, for a period of ten days because of the report that the dog had bitten Mr. Sherman's daughter. *The Sjostedt is licensed.*

The Selectmen postponed their decision until January 20, 1964.
