Sudbury Energy Project - Response to EOE/MEPA Unit

The Board reviewed a response from the Conservation Commission to the MEPA Unit, Executive Office of Environmental Affairs (EOEA), dated February 24, 1992, concerning the proposed Sudbury Energy Project, Old County Road, and pursuant to the Board's vote of March 2 it was on motion unanimously

VOTED: To direct the Executive Secretary to send a communication to the MEPA Unit, EOE/EA, requesting that a full Environmental Impact Report be prepared in conjunction with the Sudbury Energy Project proposal, expressing concurrence with the Conservation Commission's response of February 24, 1992, with additional comments suggested by Selectman Cope.

Employee Recognition Nomination

Upon recommendation of Selectman Judith Cope, it was on motion unanimously

VOTED: To approve and submit the nomination of John B. Braim, Superintendent, Parks and Grounds Management, as prepared by the Executive Secretary at the Board's request.

Hosmer Fund Expenditure

At the request of the Sudbury Historical Commission, it was on motion unanimously VOTED: To approve expenditure of \$5,765.00 from the Edwin Barrett Hosmer Memorial Fund to pay Robert Lyons, 127 Boston Post Road, Wayland, MA 01778, for cementing the Hosmer House basement; \$5,000 of this amount being drawn from the Sudbury Foundation grant for this purpose.

VOTED: To approve the minutes of the regular session of March 2, 1992, as drafted.

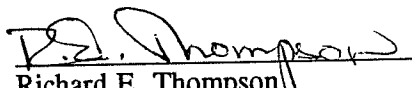
Executive Session
