## FY03 Budget Discussion

# Comprehensive Facilities Study

The Town Manager and Assistant Town Manager gave the Board a brief overview of the results of the Facilities Study recently completed.

### Town Center Planning

Present: Jody Kablack, Town Planner.

The Town Manager and Town Planner updated the Board on the status of plans for refurbishing the Town Center and intersection.

### Lafayette Drive - Robert Weiss

The Town Manager reviewed the request of Robert Weiss to acquire a portion of land within the Town-owned public way adjacent to his Lafayette Drive property. The Board confirmed it does not wish to deed this land to Mr. Weiss and asked the Town Manager to so advise Mr. Weiss of its position.

# Goodnow Farm Agricultural Preservation Restriction

VOTED: To accept the grant of an Agricultural Preservation Restriction from Goodnow Farm LLC, in perpetuity and exclusively for agriculatural and conservation purposes, on a portion of a parcel of land containing approximately 44 acres located on Goodnow Road, Lots 1-8, shown on a plan dated October 9, 2001, revised October 26, 2001, and revised twice December 3, 2001, prepared by MetroWest Engineering, Inc., and entitled " Plan of Land in Sudbury, Mass".

The Board signed the Restriction.
