IN BOARD OF SELECTMEN TUESDAY, MARCH 29, 1977

Present: Chairman John C. Powers, Ira M. Potell, and William F. Toomey

The statutory requirements as to notice having been fulfilled, the meeting was called to order at 7:30 p.m. by Chairman William F. Toomey.

Organization of the Board

Chairman Toomey opened the meeting for the business of electing a Chairman and a Clerk of the Board and to set a time and a place for meetings.

Following the nomination of Selectman Powers by Selectman Potell and the seconding of the nomination by Chairman Toomey, it was on motion

VOTED: To elect John C. Powers Chairman of the Board for the ensuing year.

Selectman Powers assumed the chairmanship.

Following the nomination of Richard E. Thompson by Chairman Powers and the seconding of the nomination by Selectman Potell, it was on motion unanimously

VOTED: To elect Richard E. Thompson Clerk to the Board of Selectmen for the ensuing year.

Following discussion, it was on motion unanimously

VOTED: That the regular meetings of the Board of Selectmen continue to be held on Monday nights at 7:30 p.m. in the Lower Town Hall.

Special and Annual Town Meetings

Chairman Powers stated that he would like to discuss with the Board tonight, in preparation for the scheduled warrant review on March 30, the Board's position on Special and Annual Town Meeting Articles.

SPECIAL TOWN MEETING - Article 1, Personnel Bylaw, Classification and Salary Plan - Chairman Powers expressed his opinion that the Town had indicated at the March 28 election a massive conservative vote, and he stated that the Board's position on non-union people would continue at 6% for FY76-77 and would provide no increase for FY77-78, and, in particular, would oppose the Personnel Board's and the Finance Committee's recommendation for additional increases for the Town Accountant and the Town Engineer.

Executive Secretary Richard E. Thompson stated that a meeting to further discuss the recommendations of the Selectmen and those of the Personnel Board and the Finance Committee has been scheduled for 7 p.m., April 4, in advance of the Special Town Meeting.

Article 2, Budget Adjustment - The Executive Secretary stated that the Finance Committee, the Personnel Board, and the Selectmen agree on all figures in the article with the exception of those for the Town Accountant and the Town Engineer.

After discussion, it was on motion unanimously

VOTED: To amend Line Item 502-10, Town Engineer to \$1,212; and it was further

VOTED; To amend Line Item 521-11, Accountant Salary, to \$1,308,

Article 3, Landham Road Land Damages - It was on motion unanimously

VOTED: To support Article 3, Landham Road Land Damages.

Article 4, Dog Pound Facilities - After discussion, during which Chairman Powers expressed the Board's reluctance to request the funds necessary to implement the Town's Dog Control Bylaw, it was on motion by Selectman Potell unanimously

VOTED: To support a request for \$25,000 under Article 4, Dog Pound Facilities, for construction of the same on Town-owned land.

Article 5 - Purchase Sudbury Skating & Tennis Club/R.A.D.I.N. Property - It was on motion by Selectman Potell unanimously

VOTED: To take strong action to defeat Article 5, Purchase Sudbury Skating & Tennis Club/R.A.D.I.N. Property.

The Executive Secretary reported that the meeting with the representatives of the Club and the petitioners, which was scheduled for March 30, had been rescheduled for Friday, April 1, at 2 p.m.

Selectman Toomey stated that the Board had altered plans to be available for the March 30 meeting and that he would now ask that the staff attend rather than the Selectmen and report back to the Board.

Mr. Thompson stated that Town Counsel Paul Kenny, Town Accountant John Wilson, and he would attend.

Chairman Powers requested that the Executive Secretary obtain the names of all employees and those persons holding concessions at the Sudbury Skating & Tennis Club so that they could be identified at Town Meeting.

Chairman Powers requested that the Board discuss when the Selectmen's statement with regard to the fiscal state of the Town should be given.

After discussion, it was the Board's consensus that the statement be made at the Special Town Meeting.

Mr. Thompson stated that he would meet with the Moderator and Town Counsel some time this week to discuss substantive rulings and review matters which may arise at the Special and Annual Town Meetings.

VOTED: To support Article 2, Temporary Borrowing.

Article 3, Personnel Bylaw: Classification and Salary Plan - It was on motion unanimously

VOTED: To oppose the 6.15% increase set forth in Article 3, Personnel Bylaw: Classification and Salary Plan.

Article 4, Personnel Administration Plan - Executive Secretary reported that the Personnel Board had agreed to delete Section 8 of Article 4 concerning collective bargaining negotiations. It was on motion unanimously

VOTED: To support Article 4, Personnel Administration Plan.

Article 5, Budget - Account 110 Sudbury Schools - It was on motion unanimously

VOTED: That Chairman Powers would make a motion to reduce the Sudbury Schools' budget by the amount of Chapter 70 entitlement not reimbursed by the State.

Account 130 Lincoln-Sudbury Regional - It was on motion by Selectman Potell unanimously

VOTED: To inform the Lincoln-Sudbury Regional High School Committee that the Selectman, at the Annual Town Meeting, intend to move the elimination from the Lincoln-Sudbury Regional budget of the item called Contingency, on advice of Town Counsel and two written statements from the Director of Accounts.

Account 320-61, Auxiliary Police - It was

on motion unanimously

VOTED: To increase Line Item 320-61, Auxiliary Police, from \$500 to \$1,500.

Account 320-51, Equipment Purchase - It was

on motion unanimously

VOTED: To request an increase from \$19,000 to \$20,000 in line item 320-51, Equipment Purchase.

Finance Committee members Philip Felleman and Alan Grathwohl expressed that Committee's opposition to Section XIII of the proposed Cemetery Rules and Regulations, with regard to the use of the particular words "rules and regulations", as in the Committee's opinion these specific words would give the Selectmen authority to establish future cemetery regulations rather than to have them adopted by a Town Meeting.

Chairman Powers pointed out that further wording in that section provided that any additional rules and regulations could not be inconsistent with law or the rules under consideration, and he further stated that any proposed new regulation would be immediately challengeable.

After further discussion, it was on motion unanimously

VOTED: To meet with the Finance Committee and Town Counsel, at a time to be arranged by the Executive Secretary for further discussion on Article 22.
