## Home Rule Charter

- Section 10. Financial Management Responsibilities: The Town Manager, with the assistance of the Finance Director and the Treasurer-Collector, shall be responsible for all the financial management functions of the Town, unless otherwise provided by this Act. Such functions shall include, but are not intended to be limited to, the following:
- a) To prepare and submit, after consultation with all Town departments, an annual operating budget and capital improvement program for all Town departments.

## Capital Planning Bylaw, Article XXV

Section 2: The CIAC shall study capital proposals which involve major tangible items with a total project cost of more than \$100,000 in a single year or over \$200,000 in multiple years and which would likely require an article at Town Meeting for the project's authorization. The CIAC shall make a report with recommendations to the Finance Committee and the Select Board on these proposals.

FY25 Town Manager's Capital Operating Budget

- All three cost centers: Town, SPS, LSRHS
- Includes requests that are:
  - Not more than \$100,000 in one year, or
  - Not more than \$200,000 over multiple years
- Items above those thresholds are submitted to Town Meeting

## **Capital Funding Sources**

#### Funding sources can include:

- Tax Levy
- Free Cash
- Overlay Surplus
- Stabilization Funds
- Capital Exclusions
- Debt in levy or excluded

#### DPW: \$50,000

New, extended or rehabilitated walkways and ADA ramps at various locations throughout Town:

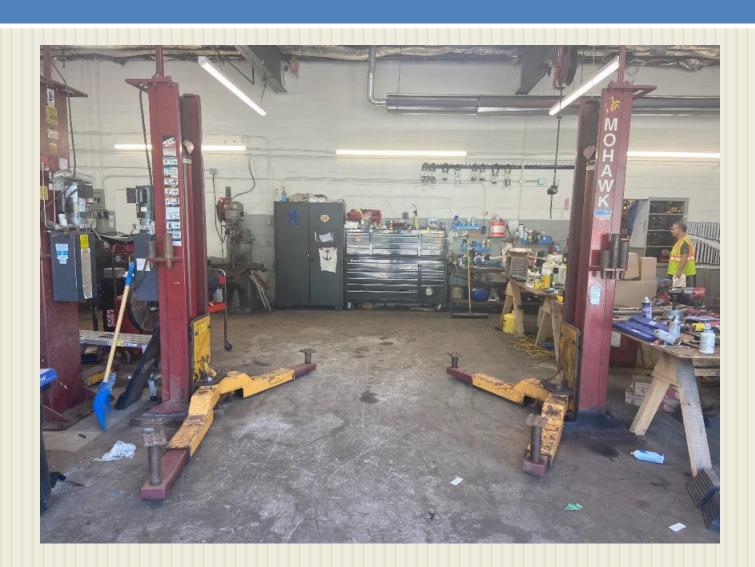
- Planning and Design

Fleet Maintenance Garage Replaces existing two-post hydraulic lift Accommodates larger vehicles Greater stability = reduced risk of injury

### DPW Truck Bay Floor Replacement – Design

Facilities: \$98,000

Deteriorated concrete floor: corrosive effect of salt

Spalling, flaking, exposed re-bar

Trip & fall hazard to employees

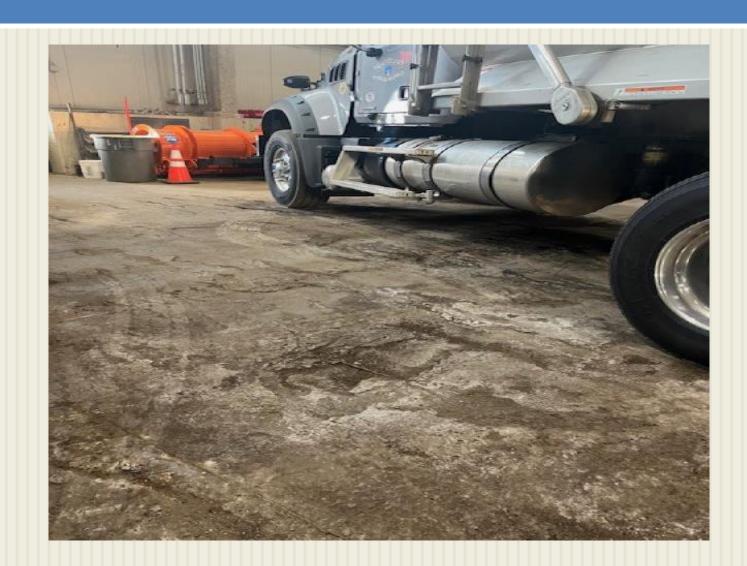
Damage to vehicles

Design funds: determine scope & cost of replacement

### Fire Station #3 Roof Replacement

#### Facilities: \$85,000

Roof is severely failing & beyond useful life expectancy \$80,000 appropriation in FY24 TM's Capital Budget FY25: Requesting Supplemental Funds New EPDM (synthetic rubber) roof to meet current energy code Solar ready

#### **Firearms Simulator**

#### Police Department: \$69,500

Virtual reality training system Training scenarios prepare officers for real life situations Training on-site at Station Software can be updated



#### **Replace WiFi Network**

#### LSRHS: \$71,197

Sudbury's share of \$81,545 (87.31%) 5-year replacement schedule – installed 2019 Maintain stability of network signals Continued growth of mobile devices = increased reliance on wireless technology for teaching, support, and administration

#### **Carpet Replacement**

Sudbury Public Schools: \$75,000

Ongoing project to replace deteriorated carpeting Work to occur when schools unoccupied

### **VCT Flooring Replacement**

Sudbury Public Schools: \$75,000

Ongoing project to replace VCT flooring

VCT: Vinyl Composite Tile

Work to occur when schools unoccupied

## Painting

Sudbury Public Schools: \$50,000

Ongoing project

Keep up with maintenance needs

Work to occur when schools unoccupied

### Paging, Clocks, & Bell Systems

Sudbury Public Schools: \$25,000

Continuation of project funded in FY22 Replacement of >20 year old systems Replacement parts no longer available Essential for communication

#### **Door Repairs & Replacements**

Sudbury Public Schools: \$50,000

Planned replacement of worn and unreliable doors Significant wear and tear on doors Maintain safety & security

### Summary

Total Town Manager's Capital: \$713,697 Funding: Tax Levy

Town Meeting Warrant Articles: >\$100,000 Total: \$4,410,550 • Free Cash: \$1,110,550 • Tax Levy: \$1,663,697 • Debt: \$2,350,000

#### **Capital Items Not Funded**

Town Manager's Capital Operating Budget:

- Town-wide Person Lift: \$75,000
- Fairbank CC Scissor Lift: \$36,500
- EV Chargers @ Goodnow Library: \$80,000

Capital Requests Over \$100,000:

- DPW Roadway Improvements: \$750,000
- Goodnow Library Bookmobile: \$200,000
- Wayside Inn Road Bridge Replacement: \$500,000

### **Additional Comments**

- Impact of inflation: Number of projects under \$100,000 continues to decline as costs escalate
- Recurring projects are more appropriately funded as maintenance items in the operating budget:
- DPW walkway design and construction
- SPS maintenance: painting, carpets, flooring, doors

Over time, concerted effort will be made to incorporate those recurring maintenance items into operating budget
