Call to Order

Town Manager Sheehan presented the "Agreement Between International Brotherhood of Teamsters, Local 25 and the Town of Sudbury, Massachusetts (Dispatchers Union), adding related negotiations ended and the Union ratified the agreement.

Town Manager Sheehan outlined the proposed incentive pay structure during this time of transition. He confirmed that seven individuals (full-time and part-time employees) would be involved in the transitional pay structure plan. Town Manager Sheehan indicated it would be ideal to maintain the existing dispatchers for the next six months.

Board Members asked related questions.

Town Manager Sheehan mentioned the dispatcher budget was reduced by \$120,000, and Chief Nix wanted to maintain coverage for the Police Station front desk.
