Chair Roberts announced the recording of the meeting and other procedural aspects included in the meeting.

Call to Order

Chair Roberts called the meeting to order at 7:05 PM, requesting Select Board Roll Call: Russo-present, Kouchakdjian-present, Carty-present, Roberts-present.

Article 43 – MBTA Buildings Acquisition

Attorney Lee Smith confirmed that related conversations with the MBTA started approximately a year ago, "Canvassing" took place to determine if any party in the MBTA agency sought the two buildings for any reason. Mr. Smith detailed that no such interest was expressed regarding the Section Tool House and the Sudbury Station Building.

Mr. Smith stated that MBTA asked if the Town of Sudbury would consider a 99-year lease term; Mr. Smith responded in the affirmative, adding that later in the term status could be changed to acquisition status. He detailed that the appropriation request is \$100.00 in consideration of future purchase. Mr. Smith confirmed that the Town had voted to acquire both buildings at the last Town Meeting.

Chair Roberts asked if there would be requirements that the Town would have to fulfill. Mr. Smith stated that the MBTA is not expecting substantive funding for the buildings.

Vice-Chair Carty motioned to support Article 43 – MBTA Buildings Acquisition. Board Member Russo seconded the motion.

Town Manager Sheehan commented that if any work/improvement are to be performed on the buildings, the Town would be responsible for related insurance coverage.

Mr. Smith noted that the Sudbury Historical Commission was seeking to include the two buildings into the Rail Trail project.
