BLUE RIBBON HOUSING SITE SELECTION COMMITTEE

MINUTES OF MEETING: OCTOBER 29, 2003

Members Present: Lydia Pastuszek (co-chair), James Gardner (co-chair), Michael Fee, Joseph Bausk, Mark Ensign, Stephen Shugrue (clerk), Rich Davison; also attending, Jo-Ann Howe (Director, Sudbury Housing Authority), Jody Kablack (Town Planner)

The meeting was called to order at 7:43 p.m. in the meeting room of Fire Department Headquarters, Hudson Rd, Sudbury.

The minutes of October 15, 2003 were approved as amended.

At the direction of the selectmen to exclude sites having deed restrictions, Ms. Kablack began collecting deeds for the Committee from the last ten years for properties on our preliminary site list. Only four deeds were received, one of which was not on our list, and no deeded purposes were found. Ms. Howe will provide deeds for the SHA properties involved. Mr. Bausk volunteered to locate deeds for the remaining properties.

Ms. Kablack committed to taking photographs of selected sites during the next suitable weather day. Such photographs are to be included in the Final Binder. Ms. Kablack will put a Legal Notice announcement in the Town Crier for the Public Forum of November 19, and it will contain a list of the selected sites. Ms. Pastuszek will write a press release. There will also be letters sent to abutters and to those across the street from the parcels.

The Committee approved with minor revisions Ms. Pastuszek's draft of the BRHSSC presentation at the 11/19 public hearing.

The Committee was informed by one of its members that its website was not up to date, and the people responsible are aware of it. Mr. Gardner agreed to communicate with the responsible persons to bring the site up to date.

The process and format of the Public Forum was discussed and the following understanding was reached: our own co-chairs will call the forum to order, moderate the meeting and adjourn the meeting. The moderators will explain the roles of the SHA (affordable housing advocates), the BRHSSC (site selectors as charged by the Board of Selectmen), and the Board of Selectmen (along with SHA as

presenters of the sites to Town Meeting). The purpose of the Forum is to present the selected sites, explain the selection process and give the public an opportunity to ask questions, offer information, and express opinions relevant to the technical issues being addressed by the BRHSSC. The time limit for speaking will be determined by how many people wish to speak.

It was decided to list two sites at Curtis Middle School (one at Pratt's Mill Road and one at Blueberry Hill Lane), and to list Washbrook and Pine Ridge separately.

Mr. Ensign will walk the 10 parcels (12 sites) as needed with Conservation Coordinator Dineen to check for obvious disqualifying conditions.

The Committee will ask for volunteers to on 11/12 to assemble the Three Ring Binder for the Report.

Ms. Pastuszek will contact the Town Manager to discuss contacting the School Committee prior to publication of the list because two of the sites need to be given that Committee's approval for transfer to the SHA.

Unanimous approval was given to publish as amended the List of Potential Buildable Sites. The 10 town-owned parcels and brief descriptions are as follows:
