


Advancing the Bruce Freeman Rail Trail Design

- FY 2018 Capital Request:
 - The Board of Selectmen is requesting \$330,000 to continue to advance the design phase of the BFRT in Sudbury.
 - A 4.4 mile section of BFRT is being designed to meet MassDOT multiuse path standards
- Funds previously appropriated allow for the completion of the 25% design (anticipated in spring of 2017) and the initiation of the 75% design phase.
- Approval of the funds for FY18 will allow for continuity in the project design without a lag in the design process.

Bruce Freeman Rail Trail Overview

- A 25-mile rail trail between Lowell and Framingham along the former Old Colony Railroad
- The corridor is owned by the MassDOT Rail Division

Phase 1, Chelmsford and Westford Completed 2009 south to Route 225.




Phase 2B, Bridge over Route 225% Design underway

Phase 2C, Concord
Construction contract awarded.

 Phase 2C, Concord south of Powder Mill Road; Construction with Sudbury Ph2D.

Phase 2D, Sudbury south to Mass. Central Crossing 25% design underway.

Phase 3(Sudbury portion AKA 2E), Sudbury and Framingham Negotiations with CSX ongoing.




Bruce Freeman Rail Trail Overview

Why pursue the BFRT?

- Provides a safe and separated recreational and commuter path
- Uses
 - Walking
 - Bicycling
 - Jogging
 - In-line skating
 - Cross country skiing and snow shoeing
- Promotes healthy communities and transportation options
- Offers connections to schools, retail districts, and other points of interest without the use of vehicles
- Regional connections



Bruce Freeman Rail Trail in Sudbury: Project Area



- In Sudbury, approximately 4.4 miles (Phase 2D)
- Intersects the Mass Central Rail Trail (east-west corridor) near Route 20
- The project in design is from the Station Road near the junction with Mass Central north to the Concord Town line

- **Bridge Inspections**


Design Process


- Order of Resource Area Delineation (ORAD) issued by the Conservation Commission on November 14, 2016
- Preliminary Design Plans
- Preliminary Structural Analysis
 - Hop Brook Bridge
 - Pantry Brook Bridge
- Parking Study
 - Davis field
 - Featherland Park
 - Ti-Sales Field
- Roadway Crossings Traffic Counts
 - Conducted safety analysis
 - Development of alternatives for each roadway crossing
 - Evaluate signal warrants

25% design (CPA and FoBFRT)	\$292,000	
75% Design - Part 1 (CPA FY2017)	\$150,000	
75% Design - Part 2 - Estimate	\$330,000	4
100% Design / PSE - Estimate	TBD
