Spring Town Meeting

In preparation for Spring Town Meeting, the CIAC has blocked off Monday nights from February 5 - March 11, 2024. February 12th will be Capital Night where the Select Board, CIAC and Finance Committee will hear presentations from the department heads as they present their warrant articles.

CIAC Future Operations

There has been some speculation as to the future of the CIAC and whether or not it may be eliminated. In order to dissolve the CIAC, an article must be presented and a vote taken at Town Meeting. Tom Travers explained that historically, the Finance Committee looked at the operating budget and the CIAC reviewed all other capital items. The process has evolved, resulting in some overlapping of efforts by the CIAC and Finance Committee. Susan Asbedian-Ciaffi suggested that maybe instead of dissolution of the CIAC, the CIAC might have an expanded mandate to review capital items, and the Finance Committee take that research and recommendation without further investigation, so as to eliminate some duplication of work.

Director Duran gave a quick update on the pool warrant article for Town Meeting and status of the Fairbank Community Center. Director Duran offered to give CIAC members a tour of the facility; date and time set for noon on Thursday, 1/25/24.

Next meeting is scheduled for Monday, 2/5/24, at 6:30pm on Zoom, if there are warrant articles ready to be reviewed.
