## 2025 ANNUAL STREET LISTING (TOWN CENSUS)

#### **INSTRUCTIONS**

**A – VOTER**: If there is an asterisk (\*) in this column, that person is a registered voter in Sudbury.

B – NAME: List all persons whose legal address is at the top of the form. Please confirm that this census reflects all residents living at your household including minors, residents away at school, in the military, or in a medical facility.

C – MAIL TO: Place a "Y" in this column next to the mailing contact's name if one is not designated. Or you can cross out and change which resident is the mailing contact if desired. Only one mailing contact is allowed.

**D – DATE OF BIRTH**: Use the month/day/year format.

**E – OCCUPATION:** Enter occupation, not the place of employment. Enter "Student" for those enrolled in school or college. Enter "Child" for those younger than school-age.

**F – NATIONALITY**: Enter only if *NOT* a U.S. citizen.

**G** – **MOVED/DECEASED**: M = Moved, D = Deceased. If a member of the household has moved permanently from Sudbury and is a registered voter, provide a forwarding address on the front page with their signature so that it can be processed. Only if the voter themselves signs will they be removed from the census/voter rolls, otherwise, they will remain on the census/voter rolls. **H – U.S. VETERAN**: Enter X if the individual is a veteran. Otherwise leave this field blank.

#### **IMPORTANT:** THIS FORM IS NOT A VOTER REGISTRATION

- This form **DOES NOT** register you as a voter or allow you to change your political party. You may register to vote by scanning the QR code, online at www.registertovotema.com, or in person at either the Town Clerk's Office or the Registry of Motor Vehicles.
- You must be a US Citizen and 18 years of age by the next election date in order to become a registered voter. If you are not yet 18, you may pre-register beginning at age 16 and will be registered on your 18<sup>th</sup> birthday.



### **DOG INFORMATION**

- Enter the number of dogs in the household, not pet names.
- DOGS AGE 6 MONTHS AND UP MUST BE LICENSED ANNUALLY WITH THE TOWN. A DOG LICENSE APPLICATION IS ENCLOSED FOR YOUR CONVENIENCE.
- April 2, 2025 is the deadline to register your dog without a late fee.
- Dogs new to Sudbury must be registered by mail or in person. Dogs previously licensed in Sudbury may be renewed online at: https://sudbury.ma.us/dog.
- The Town Bylaws under Chapter 117 Article II require dogs to be under restraint. Restraint, when outside the premises of the owner, is defined as being accompanied by a person who shall have the dog under control by holding firmly on a leash no greater than six feet in length. Dogs are not permitted to be off leash at any time, other than when on the owner's premises, but must still be under control or in a suitably enclosed area, including electric invisible fencing.
