Re: MADEP File No. 301-1231 Subsurface Investigation Notice of Intent Sudbury-Hudson Transmission Reliability Project

Dear Chairman Friedlander and Commission Members:

Nover-Armstrong issued a comment letter on July 31, 2018, that addressed the July 16, 2018 supplemental submission made by Eversource and VHB. The supplemental submission included a response to comments from both the Commission and Nover-Armstrong. The plans that accompany the NOI were not revised because the review of the ANRAD application, and therefore boundaries of wetland resource areas, was still ongoing. Since the supplemental submission, the Commission voted to issue two Orders of Resource Area Delineation (ORAD) and approved all wetland resource area boundaries. Accordingly, the NOI plans were revised with the approved boundaries per Nover-Armstrong's request and three full sets are included with this submission.

In addition, the impact numbers were recalculated based on the approved wetland resource area boundaries. The Project will result in 58 subsurface activities and 36 tree removals within the Commission's jurisdiction. Shrub and sapling removals will also occur throughout jurisdictional areas. Below is a table summarizing regulated activities per sheet (see Table 1) and a table summarizing regulated activities per sheet (see Table 1) and a table summarizing regulated activities per resource area (see Table 2). Please note that in Table 2, impacts are broken out by resource area, so areas of vegetation removal and/or subsurface activities may appear in more than one resource area (e.g. B38 on sheet 16 is in RFA and the wetland buffer/AURA and all activities within the vernal pool buffers are within wetland buffers).
