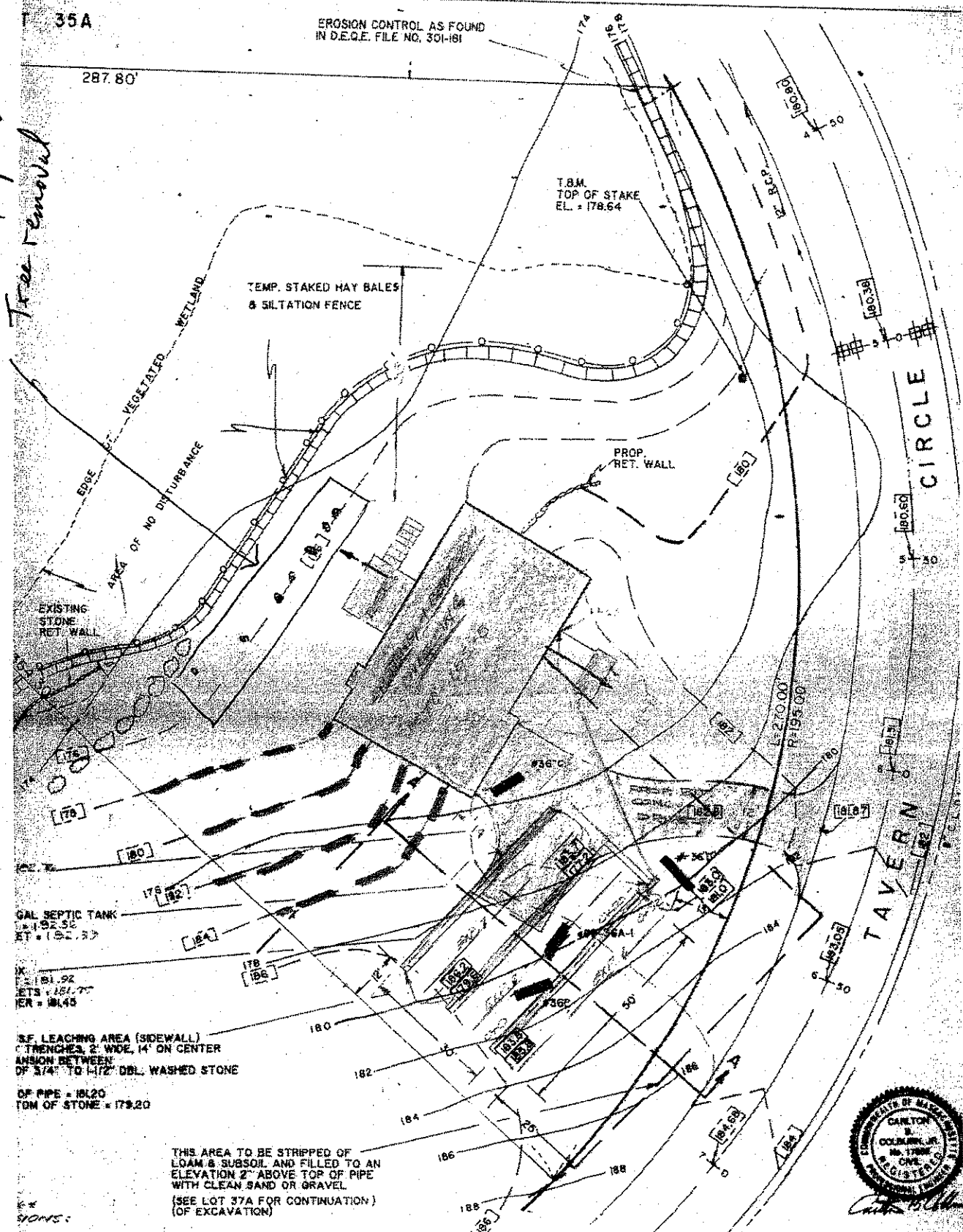

Tree removal*



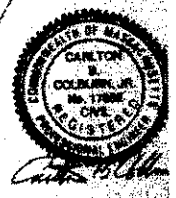
