**Re: Second Response to Peer Review of Stormwater Management Permit Application  
Nobscoot Scout Reservation Trail Improvement Project  
1 Nobscoot Road, Sudbury, MA**

Dear Mr. Duchesneau and Board Members:

Howard Stein Hudson (HSH) has reviewed the Horsley Witten Group comments on behalf of the Town of Sudbury dated October 27, 2022 and offers the following responses:

**Sheet 3 (4) of 21 (22): Legion Cabin and Gen John Nixon Trail – Station 112+00 to 118+00**

**1<sup>st</sup> Comment:** *Review use of firewood in Conservation Restriction, may be okay to use down trees but this should not be considered an automatic approval.*

**2<sup>nd</sup> comment:** *The Applicant has clarified the use of downed trees for firewood. HW does not have a copy of the Conservation Restriction to confirm the proposed use. HW defers further discussion to the Conservation Commission.*

**Response:** **Not all downed trees are used for firewood. Most downed trees left in place to provide habitat for wildlife.**

**Sheet 4 (5) of 21 (22): White Ridge Trail – Station 119+00 to 125+00**

**1<sup>st</sup> Comment:** *Excessive sediment on trail to be removed.*

**2<sup>nd</sup> comment:** *HW comment stands, however we understand from our site visit this is the intent*

**Response:** **The erosion controls in place and all disturbed areas will be continually inspected and any sediment build-up will be removed.**

**1<sup>st</sup> Comment:** *Concern with invasives within swales after land disturbance. Hydroseed immediately and monitor.*



**2<sup>nd</sup> Comment:** *The Applicant has indicated hydroseeding has been included as part of the stabilization plan. It also noted all graded areas will be monitored for invasives. The Conservation Commission may choose to include this as a Special Condition.*

**Response:** The applicant has agreed to monitoring the invasives within the work zone using Lucas Environmental.

**1<sup>st</sup> Comment:** *Level spreader may be needed around Station 124+25 to slow flow and reduce erosion.*

**2<sup>nd</sup> Comment:** *The Applicant has stated that a level spreader has been added. However, it is not called out on the plan. HW recommends that the Applicant call out the level spreader and provide a detail.*

**Response:** A precast concrete level spreader and detail has been added to the plans.

**Sheet 5 (6) of 21 (22): Monson Trail – Station 400+00 to 407+00**

**1<sup>st</sup> Comment:** *HW recommends installing water bars along trail with professional oversight.*

**2<sup>nd</sup> Comment:** *The Applicant added additional water bars to the area. The Conservation Commission may choose to require professional oversight wherever water bars, check dams, or level spreaders are proposed.*

**Response:** The installation of the level spreader will be over seen by the Project Engineer from HSH.

**1<sup>st</sup> Comment:** *Sediment in path around Station 403+75 should be removed and replaced with stone. Document where sediment that will be removed will be placed temporarily and permanently.*

**2<sup>nd</sup> Comment:** *The Applicant has stated that sediment removed from the area will be moved off-site to a maintenance facility. It has also stated that any stockpiled areas will be located outside the wetlands and buffer areas. The Conservation Commission may choose to include restrictions to the location of stockpiles as a Special Condition. It may be useful to have the restrictions included on the cover sheet.*

**Response:** Comment noted, Commission to make the determine on any special conditions.

**Sheet 8 (9) of 21 (22): Legion Trail – Station 1+00 to 8+00**



**1<sup>st</sup> Comment:** *Placement of 6-foot-long concrete footings for wooden platform at Station 1+00 to be done by hand. Other footing types instead of heavy concrete footings may be considered.*

**2<sup>nd</sup> Comment:** *The Applicant has noted that this area may be in water for extended periods and considered concrete may be the most practical. It has noted all work in this area to be completed by hand. The Commission may choose to include as a Special Condition that the work is to be conducted by hand or it may prefer that the Applicant add a note to the plan.*

**Response:** **A note has been added to the plans specifying that bridge footings proposed within wetlands should be installed by hand. Installation of the bridge will be overseen by the project engineer.**

**1<sup>st</sup> Comment:** *Applicant to review all areas of land disturbance. Areas within wetlands receiving stone should be considered a permanent impact and not temporary.*

**2<sup>nd</sup> Comment:** *The Applicant has noted that areas of compacted paths being restored with stone within wetland areas are previously impacted and should not be considered temporary. Furthermore, it states areas within wetlands with stone cover would not require replication as there is no wetland loss at this location due to an existing trail. It is HW's opinion that any wetland area receiving crushed stone should be considered a permanent impact. The wetland areas where crushed stone exists and is being replaced may be considered temporary impacts.*

**Response:** **This issue was discussed in the field with members of the Conservation Commission and the Conservation Commission Agent. HSH considers the placement of stone within the existing trail limits as a temporary impact as the wetland has already been degraded by its use as a trail. If, however, the placement of stone changes the grade by more than 12-inches it is assumed that this is a permanent impact and loss of wetland as it removes its hydraulic connection to the surrounding wetland. In this event as discussed in the field, rather than clear vegetated areas to provide replication areas a more robust invasive species monitoring program will be put in place.**

**Sheet 9 (10) of 21 (22): Muskie Trail – Station 9+00 to 15+00**

**1<sup>st</sup> Comment:** *Applicant to review all areas of land disturbance. Areas within wetlands receiving stone should be considered a permanent impact and not temporary. Culvert crossing is permanent impact.*



**2<sup>nd</sup> Comment:** *The Applicant agrees that the proposed culvert crossing is a permanent impact. However, it has noted that areas of compacted paths being restored with stone within wetland areas are previously impacted and should not be considered temporary. It is HW's opinion that any wetland area receiving crushed stone should be considered a permanent impact. HW agrees that the placement of the crushed stone is beneficial to avoid widening of the trail from pedestrian traffic. However, we still consider it a permanent impact.*

**Response:** **This comment is very similar to the previous comment. A more robust invasive species monitoring program will be put in place.**

**1<sup>st</sup> Comment:** *Invasive species in this area are a concern, including poison ivy, specifically north side of trail for 25 feet beyond proposed grading, south side is also a problem but not as severe. Invasive management plan should be reviewed with Conservation Commission. Replant disturbed area with shrubs and spray seed mix. Weed Warrior program was discussed. Applicant should explain how it intends to restore the temporary impacts to the wetlands in this area.*

**2<sup>nd</sup> Comment:** *The Applicant has stated temporary impacts are to be loamed and hydroseeded with a wetland seed mix. Upland areas will be hydroseeded. It also noted the goal for volunteers to be trained to identify invasives. The Conservation Commission may choose to include management of invasives along the trail as a Special Condition.*

**Response:** **As previous discussed at the last NOI hearing, the intent and agreement is to have Lucas Environmental provide invasive management over the work areas, while the volunteers in coordination with the SVT (weed warrior program), Lucas Environmental, and the Sudbury Conservation Agent will define an invasive management plan for a larger areas of the trail system, outside of the work zones.**

**1<sup>st</sup> Comment:** *There is a trail to the Peabody Camp site. Questions were raised during site walk on how this trail is accessed by the campers with special needs.*

**2<sup>nd</sup> Comment:** *The Applicant has stated that the trail system is not ADA accessible and groups with special needs will need to coordinate access with Mayflower Council's Camping and Program Director. HW defers further discussion to the Conservation Commission.*

**Response:** **There is an ADA accessible cabin at the main entrance to the trail system. Any other special arrangements for people with accessibility issues are coordinated with Camp staff before arriving at the reservation.**



**Sheet 10 (11) of 21 (22): Little Sachem Bridge, Legion Trail – Station 16+00 to 17+00**

**1<sup>st</sup> Comment:** *Keep utility pole acting as headwall.*

**2<sup>nd</sup> Comment:** *The Applicant has stated that the utility pole will need to be removed for installation of the bridge footing and joints. It is not clear on the plans where the utility pole is located and whether it will be replaced. HW recommends that the Applicant provide clarification.*

**Response:** All utility poles used as a headwall (spacers) between the utility pole joists beams are to be removed are replaced with timber spacers (2"x12") that will act as a headwall. The location of the existing utility pole headwalls have been added to the plans.

**Sheet 16 (17) - 18 (19) of 21 (22): Gen John Nixon Trail – Station 200+00 to 226+00**

**1<sup>st</sup> Comment:** *Applicant to review all areas of land disturbance. Areas within wetlands receiving stone should be considered a permanent impact and not temporary.*

**2<sup>nd</sup> Comment:** *The Applicant has noted that areas of compacted paths being restored with stone within wetland areas are previously impacted and should not be considered temporary. It is HW's opinion that any wetland area receiving crushed stone should be considered a permanent impact. HW agrees that the placement of the crushed stone is beneficial to avoid widening of the trail from pedestrian traffic. However, we still consider it a permanent impact.*

**Response:** This comment is similar to others and has previously been addressed.

**Sheet 20 (21) of 21 (22): NIPMUC Trail – Station 314+00 to 319+00 and Belden Bridge**

**1<sup>st</sup> Comment:** *Area that appears to be used by dogs to access stream should be planted with native vegetation that will discourage access. Within or adjacent to proposed wetland mitigation area.*

**2<sup>nd</sup> Comment:** *The Applicant has stated this may not be a deterrent enough to stop dogs from entering the stream and suggests signage. HW agrees signage would be helpful for leashing dogs. HW still recommends plantings as a physical barrier to the stream area. HW defers to the Commission on any conditions implemented for this location.*



**Response: Elderberry bushes have been added along the trail to protect the wetland replication area adjacent to the Belden Bridge and deter dogs and pedestrians from accessing the stream in this area.**








**ANGLED WATER BAR (TYPE 1) PLAN VIEW**




**PERPENDICULAR WATER BAR (TYPE 2) PLAN VIEW**


