Sudbury ADA Plan Executive Summary	Dave gave the group his document detailing the need for an ADA and Transition plan in Sudbury.	The group liked the draft, but suggested that Dave add specific numbers to the last paragraph to demonstrate the risk Sudbury takes in not being in compliance. If the selectmen back the idea of having a consultant draw up the plan, the Commission will need to prepare and article for Town meeting. The League of Women Voters might take this on as a project closer to the next Town Meeting.	Dave will add the numbers, and ask for final comments. Haskell Field	The adult exercise portion of the field is underway, and was asphalted today. Exercise stations have been ordered. An examination of the existing sidewalks which form part of the walking loop reveals that they are deteriorated, with many large gaps in paving, damage from tree roots, and in one case actually has walkers using the road as part of the loop. In addition there are puddle and drainage issues and a potential safety issue if existing large rocks are not enough of a barrier for traffic.	The grant from Boundless Playgrounds has been received for \$125,000. There will be a meeting from the grantors to teach Dennis Mannone, Lottie, Dave, and John Jalbert the requirements of using the grant money. The goal is to have a fully accessible park with areas for three ages of children, the adult walking loop and exercise stations, and other facilities all fully accessible.
