Dina mentioned the DASH program regarding disability education for school aged children. Guest Jackie Kilroy was attending for her second time because she is interested in becoming a member of the Commission on Disability. Jackie stated that she has a disability (epilepsy) and that she is sensitive to conditions affecting people that are often overlooked by non-disabled people. One of her goals is to educate and advocate for people with convulsive disorders. SCOD members then introduced themselves. Susan, Peter, Lotte and Ben each gave a brief introduction and personal background.
