5. DISCUSSION/ACTION: Preferences and priorities for spending American Rescue Plan Act (ARPA)

funds and consider composing a statement to be delivered to the Select Board

- American rescue plan act (ARPA) funding

Town receive 5.9 million and dept are vying for some of the money.

Discussion ensued:

Select board and town manager soliciting feedback- the town has ½ of the money. Select Board has a high level discussion to assess what is appropriate use of the money.

Discussed the flash vote the town issued and included brief info and thoughts about ARPA money – discussion has widened to include more town members

Kay Bell shared the ARPA plan with funding objectives Treaurey.gov quick reference ARPA public health, lost funding for public sector, lost revenue, guide; covid impact, premium pay for essential workers, water sewer, broadband

## Suggestions included:

- Lisa Kouchakdjian suggested to focus on essential workers town social worker/MH/ nurses, schools
- The food pantry and to update space,
- Enhanced transportation for people with disabilities (40% of people who use transportation are people with disabilities.)
- People with disabilities often have medical and financial concerns these things speak to our mission.
- Can Sudbury use the ARPA \$\$ to offset the increased costs of building?
- Suggestion to make a list of items that speak to our mission and present to Select Board.
- Social isolation problem for older population- support staff and programming?

Peg Espinola Council on Aging - joined the meeting at 7:50 and made a proposal that COVID has limited work at the community center- Asked for things to be put back in that aligns with the community center. Also supportive of Bethany Havdad getting more support.

Select board and town manager to collate the suggestions looking for overlap and compile the requests into something cohesive.

Lisa Kouchakdjian -suggests Kay Bell draft and send a letter to Select Board and Town Manager-important issues for the town to consider in regard to the ARPA money including: Social worker, nursing, transportation, mental health support, COA/community center building- retrieving what has been cut, sidewalks/accessible/recreation spaces.

Lisa Kouchakdjian made a motion to authorize Kay draft the letter as discussed with regard to ARPA funds and send the letter to the town manager and to sign for the COD
