Subject: Follow-up on Sudbury's FY2023 Municipal ADA Improvement Grant applications

Hi, all.

Summary: Sudbury's submissions for the FY2023 Municipal ADA Improvement Grant were excellent grant applications, and we should try again next year when more funding is available.

Detail follows.

After learning last February that Sudbury had not been awarded any of its applications for the 2023 Municipal ADA Improvement Grant Program which we submitted last September, I requested guidance from the Massachusetts Office on Disability (MOD) on how we could make our applications more successful in the future. Although during the February/April time period his office is generally focused on administering grant awards Evan George, MOD's ADA Grant Compliance Coordinator, responded on Tuesday, April 25, and we spoke by phone for twenty minutes or so. I really appreciate his time and the information I received.

For context, the three projects for which we applied were:

(1) Accessible Water Fountain Installations in Town and PreK-8 Schools — requested \$201,000

(2) Accessible Pathways to Athletic Fields,

Accessible bench and picnic seating areas on the grounds of Town and PreK-8 Schools — requested \$250,000

(3) Assisted Listening Devices in Town and PreK-8 School meeting rooms and auditoriums — requested \$93,300

Note that \$250,000 is the maximum grant award for one project under this program.

For the 2023 grant cycle the MOD received approximately \$11 million in grant requests for which there was approximately \$3 million in available funding. In addition to this highly competitive situation, there were numerous requests for extensions by

communities that experienced various delays in using previous awards. The MOD's focus was on funding municipal requests for self-evaluation and transition plans.

Specifically, Sudbury's grant applications were both complete and accurate. (I gather this is not always the case.) Mr. George particularly mentioned the itemization of project costs and the detailed explanation of how these were derived we included in the application as exemplary. He appreciated receiving separate grant requests for different projects so they could be considered independently. However, he also mentioned that this was the first year that Sudbury had applied for a "project" grant to implement the transition plan. When comparing Sudbury's requests with those of other communities that had applied for similarly-compelling project grants previously, the others had an edge from simple commitment. Mr. George suggested that we try again next cycle to receive grants for these projects or others in our plan, and that we state that we have previously applied for grants we did not receive (when and how often). He acknowledged that this is a very quick grant cycle (essentially opening in July/August and closing by the end of the following June), which makes it challenging both to apply for grants are awarded.

The hope is that the grant funding available for next year's (FY24) cycle will be increased to \$4 million.

Mr. George sent me the link to the grant awards that were announced for the FY23 cycle

I observe the only MetroWest town to receive a project grant was Acton, which received \$85,000—that is, less than the amount requested for Sudbury's smallest project.

I hope we on COD can assist in this process by supplying the Facilities Manager with whatever support she requests in future rounds of grant application. Thank you both, Facilities Manager Duran and Interim Town Manager Bilodeau for your both your hard work and the excellent grant submissions under tight time constraints.

I just wanted to share this update with everyone involved.

Apr 2023

- Phone COD: Mother of two disabled sons seeking assistance filling out MassHealth and SSI applications. Kay called, left message. Info about online assistance with applying for Mass Health.
- 2. Phone: Resident with multiple sensory disabilities reported inability to access Town Meeting Warrant. Kay communicated with Town staff on gap and followed up to connect resident with staff and information about options for participating in Town Meeting. Access to the Town Meeting Warrant on the Town website remained not screen reader friendly so Kay converted select sections of interest in the Warrant to screen readable formatting and sent them to the resident.

- 4. Phone COD & email: Mass DOT Office of Public Engagement, will send info and poster about March 2, 2023 Rail to Trail Public Listening Design event asking to post on social

media and/or website. Called and said yes. Gave info for contacting The Coolidge. Flyer posted to COD facebook page.

Jan 2023

- 1. Email: Request transportation info. Parent of young adult w/disability who works in town and needs independent ride to and from work. Sent info about GoSudbury and contact info, same day. Sent follow up inquiry three weeks later.

M.G.L. Ch. 40, s.8J: Disability commission; powers and duties...

...may establish a commission on disability, hereinafter called the commission, to cause the full integration and participation of people with disabilities in such city or town.

Such commission shall

(1) research local problems of people with disabilities

(2) advise and assist municipal officials and employees in ensuring compliance with state and federal laws and regulations that affect people with disabilities

(3) coordinate or carry out programs designed to meet the problems of people with disabilities in coordination with programs of the Massachusetts office on disability

(4) review and make recommendations about policies, procedures, services, activities and facilities of departments, boards and agencies of said city or town as they affect people with disabilities

(5) provide information, referrals, guidance and technical assistance to individuals, public agencies, businesses and organizations in all matters pertaining to disability

(6) coordinate activities of other local groups organized for similar purposes

MGL Chapter 40 Section 22G: Funds received from fines for handicap parking violations, deposits in account, expenditures, reporting

Any city or town which has accepted the provisions of section eight J is hereby authorized to allocate all funds received from fines assessed for violations of handicap parking in said city or town to the commission on disabilities.

Funds so received shall be deposited by the city or town treasurer in a separate account and shall be used solely for the benefit of persons with disabilities. Said account shall be established by the city or town treasurer and shall be kept separate and apart from all other monies.

Expenditures from said account, including accrued interest, if any, shall be made upon the recommendation of the commission on disabilities in accordance with the accepted procedures of the city or town for the disbursement of funds, including the approval of the mayor and city council or the town manager or board of selectmen.

The city or town accountant shall submit annually a report of said account to the mayor and city council or the town manager and board of selectmen for review and a copy of said report shall be forwarded to the bureau of accounts.

Draft motion for COD spending guidelines

Move that

- All funds accrued by the COD in any accounts shall be expended in conformity with the functions stated in MGL Chapter 40 Section 8J after the phrase "Such commission shall".
- All funds accrued in Handicap Parking Account, HANDI PARK 118357 | 522100, shall be expended in accordance with the stipulations of MGL Chapter 40 Section 22G.
- If funds accrued from sources other than Handicap Parking fines are received with limiting conditions for use, those conditions must conform with the purposes set out in MGL Chapter 40 Section 8J. Such funds shall be expended for the purposes specified.
- 4. All consideration of and decisions for expending COD funds shall be conducted at public meetings.

TOWN of SUDBURY AMERICANS WITH DISABILITIES ACT MUNICIPAL GRIEVANCE PROCEDURE

This Grievance Procedure is established to meet the requirements of the Americans with Disabilities Act. It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in employment practices and policies or the provision of services, activities, programs, or benefits by the Town of Sudbury.

The complaint shall be in writing and contain information about the alleged discrimination such as name, address, phone number of complainant and location, date and description of the problem. Reasonable accommodations, such as personal interviews or an electronic recording of the complaint, will be made available for persons with disabilities who are unable to submit a written complaint.

The complaint should also include the name, address, phone number of the complainant or their authorized representative. The complaint should be submitted by the complainant and/or their authorized representative as soon as possible but no later than 60 calendar days after the alleged violation to:

The following timeline may be extended by mutual agreement of the grievant and the ADA Coordinator or Town Manager:

Within 15 calendar days after receipt of the complaint, the ADA Coordinator will meet with the complainant to discuss the complaint and possible resolutions. Within 15 calendar days after the meeting, the ADA Coordinator, will respond in writing, and, where appropriate, in a format accessible to the complainant, such as large print, braille, or audio recording. The response will explain the position

of the Town of Sudbury and offer options for substantive resolution of the complaint.

If the response by the ADA Coordinator does not satisfactorily resolve the issue, the complainant and/or their designee may appeal the decision of the ADA Coordinator within 15 calendar days after receipt of the response to the Town Manager at <u>TownManager@sudbury.ma.us</u> or (978) 639-3385.

Within 15 calendar days after receipt of the appeal, the Town Manager or their designee will meet with the complainant to discuss the complaint and possible resolutions. Within 15 calendar days after the meeting the Town Manager or their designee will respond in writing, and, where appropriate, in a format accessible to the complainant, with a final resolution of the complaint.

All written complaints received by the ADA Coordinator, appeals to the Town Manager or his/her designee, and responses from the ADA Coordinator and Town Manager or his/her designee will be kept by the Town of Sudbury for at least three years.

Gifts Of Hope collaborates with town social workers, Voices against Violence, and other domestic violence shelters who identify families struggling with meeting their most basic needs.

We are contacted by service providers with requests for household goods, groceries, and help with urgent financial needs. Items requested are located on Facebook market place, Craigs List, community bulletin boards, community organizations such as the League Of Women Voters, Garden club, faith-based organizations, personal friends and acquaintances.

Financial Access Program

Those impacted by relationship violence often have limited financial resources with which to establish a new home and care for their children. This program provides the necessary monetary funds to help victims with rent, transportation, and legal costs.

Product Access Program

Local social workers or domestic violence service provider agencies work with survivors to make a list of the household goods, furniture, and clothing they need. GOHU then searches for or buys the items so that clients don't have to call around to multiple agencies.

The request to Sudbury Foundation

In 2022, GOHU provided over \$25,000 in gift cards alone to Sudbury based clients. We expect that this need will not be reduced in 2023, having regard to inflation and the increase in utility bills. We have therefore applied for a grant of \$15,000 from the Foundation to allow us to keep supporting these clients.

Dear Sudbury Foundation Board Members:

The Sudbury Commission on Disability (COD) submits this letter of support for the Gifts of Hope Unlimited grant request with wholehearted appreciation for the direct assistance the organization has been providing and will continue to provide for families experiencing the impacts of relationship abuse.

For a large fraction of the client families, disability is a factor in the complexity of their situations. Sometimes the stresses that may arise when a child enters the family with a disability can become a tipping point from a healthy relationship over to a fraught and then abusive relationship. Sometimes one or both adults in the family may be living with a disability, either apparent and physical or unseen and possibly emotional, cognitive, or involving mental health, and that can be a factor that pushes the relationship into that abusive zone.

For those families that have left the abusive relationship and become survivors, disability of a family member or members adds a layer of challenge to reaching that properly resourced, safe, and empowered future that is the expressed goal of Gifts of Hope Unlimited. We on the COD believe that the multifaceted, direct support Gifts of Hope Unlimited can extend to bridge the gaps that appear from time to time for their client families is what can make all the difference between falling into disarray and dependency and carrying the progress forward to that brighter, healthier outcome.

The Commission on Disability does not have provision of direct service in our statutory mandate. We do have collaborating with and supporting community groups who help improve inclusion and access for people with disabilities in our mandate, and so it is that we offer our emphatic support to the grant request of Gifts of Hope Unlimited, as they are truly expanding the options and potentials for vulnerable members of our community, many of whom are living with disabilities.
