1 ESCO Update & Plans

The proposed Energy Services Agreement was reviewed with the Capital Improvement Committee on March 12th and the FinCom on March 17th.

The Capital Improvement Committee agreed to support the Energy Services Agreement and the projects it would cover.

The FinCom, after evaluation and discussion at two previous meetings, voted unanimously to support the Energy Services Agreement at town meeting.

ACTIONS:

2 Green Communities Grant – Project candidates, status & plans

Significant discussion revolved around potential candidates for inclusion into the April Green Communities Grant application.

The current project candidates include:

- 1) LED parking lot and outdoor building lights for LSRHS
- 2) LED Streetlights town wide for Sudbury
- 3) Goodnow Library retro-commissioning
- 4) Replacement of Fairbank Community Center roof top unit with energy recovery unit

Required for the grant application is a narrative describing each project including its implementation plan along with details of the project cost, applicable utility rebates and modeled energy savings.

- 2) Ed to send Jim C background data on the LSRHS LED project.
- 3) Jim K. to distribute project information on the Fairbank RTU when available
