#### **Sudbury Sustainability Director Role**

Take a lead role in preparing a written Climate Mobilization Action Plan; Develop a comprehensive set of sustainability goals and track over time; Identify short-, medium-, and long-term goals to reduce community-wide GHG emissions; Manage grant applications; Coordinate the implementation of the projects; Promote specific sustainability and conservation projects to residents and businesses; Work with private, nonprofit entities and municipalities to collaborate and create solutions to sustainability challenges. Create a Town website, write articles for newsletters, and social media outlets for residents looking for information on sustainability practices and assistance. Send an annual report on progress toward sustainability goals to Sudbury officials.
