capital in the levy and prioritization of projects.

Jennifer Roberts was recognized by Co-Chair Poch. She explained that "cash capital" are sources that don't include debt and added detail about the use of the Capital Stabilization Fund. Ms. Roberts also volunteered to help facilitate a joint meeting soon to discuss the capital process.

Susan Ciaffi, Chair of the CIAC, was recognized, and she agreed that it would be helpful to have a meeting soon that includes representatives from the FinCom, the Select Board, and CIAC, as well as the Town Manager and the Finance Director, to discuss the capital process.
