This is regarding the proposed Sudbury-Hudson Electric Line & Rail Trail project located along a paved public roadway and within an existing, inactive railroad right-of-way in the communities of Sudbury, Marlborough, Stow and Hudson, Massachusetts. Thank you for your comment letter dated October 25, 2021 regarding adverse effects to historic properties and the Central Massachusetts Railroad Corridor Historic District.
