The **Sudbury Housing Authority**, the Awarding Authority, invites sealed bids from **General Contractors** for the **667-1 Selective Siding Replacement, #288060** in Sudbury, Massachusetts, in accordance with the documents prepared by **Richard Alvord Architects**.

The Project consists of: Selective removal of shake siding, window and door trim, watertable and other exterior materials and installation of new; painting new materials to match existing and remaining.

The work is estimated to cost **\$118,000**.

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.

General bids and sub-bids shall be accompanied by a bid deposit that is not less than five (5%) of the greatest possible bid amount (considering all alternates), and made payable to the **Sudbury Housing Authority**.
