ADVERTISEMENT TO BID

The **Sudbury Housing Authority**, the Awarding Authority, invites sealed bids from **Contractors** for the **667-1 Utility Cable / Transformer Replacement (Site), #288064** in Sudbury, Massachusetts, in accordance with the documents prepared by **BLW Engineers, Inc.**.

The Project consists of: Electrical Work:

1. Replace medium voltage cable between 4 transformers; providing required trenching to allow new feeders to be installed.
2. Coordination with utility company for the replacement of two pad-mounted transformers.
3. Removal of existing feeders being replaced.
4. Providing of backfill of trenching; reseeding of grass areas, patching of bituminous where required.
5. Provide concrete for feeders under roadways.
6. Provide all conduits required between transformer; all conduit elbows.
7. Provide disconnection of existing ground grids to allow removal of existing transformers, by Utility Company; provide re-connection of grounding to new transformers.

The work is estimated to cost **\$125,075**.

Bids are subject to M.G.L. c.30§39 & to minimum wage rates as required by M.G.L. c.149 §26 to 27H inclusive.

General bids shall be accompanied by a bid deposit that is not less than five (5%) of the greatest possible bid amount (considering all alternates), and made payable to the **Sudbury Housing Authority**.
