### **GENERAL CLARIFICATIONS**

1) Question: The RFP states a requirement as follows, "Evidence that liability insurance in the

amount specified herein will be in force upon contract execution". Where can one find

the amount specified?

Answer: SHA would like firms to submit a Certificate of Insurance showing their coverage for

Commercial General Liability, Automobile, Workers Comp, and Professional Liability.

2) Question: Addendum 1 included an attachment referring to the list of plan holders. Was there a

preliminary application or a registration process that interested firms needed to

complete?

Answer: No, there was neither a preliminary application nor registration process. The list of plan

holders contains the firms that attended the virtual briefing session on January 9<sup>th</sup>, 2025

and provided their contact information prior to exiting the meeting. All proposals

received will be given the same review process.
