6 Village at Old County Road, unit 11**

This packet contains specific information for the purchase of a deed restricted unit – Unit 11, the Village at Old County Road development in Sudbury, MA – the eligibility requirements, the selection process, and a lottery application form.

The key milestones for this housing opportunity:

- Application Period opens Monday November 2, 2020
- Application Deadline Friday November 13, 2020, 12pm
- Lottery Friday November 20, 2020, 11am, *via online meeting – details for joining meeting provided to eligible applicants via email*

This application is a first step in the lottery process and does not assure you a home. Applicants must secure approval for a mortgage loan, submit evidence of such approval together with the application, and be ready to buy.

Project description

The Villages at Old County Road condominiums consists of 37 townhouses off of Route 20 in Sudbury, a suburban town 20 miles west of Boston, with top-ranked schools. This affordable and attractive unit with 2-bedroom 2 ½ bath unit contains approximately 2,176 square feet of living space on two levels, with a basement. Parking includes a direct entry garage for one car, and space for one car directly in front of it.

The first floor offers an open floor plan with cathedral ceiling and skylight in the family room, a dining room and a large modern eat-in kitchen with breakfast bar peninsula, recessed lighting and wood floors, a private den/study and a half bath. The kitchen and bathrooms have attractive wood floors. The kitchen opens to a private deck. The unit comes as is, with a refrigerator, gas range/oven, microwave and dishwasher. The second floor offers a Master bedroom suite with generous closets, and large Master bathroom; 2nd bedroom, a loft area, and another full bath. Washer and dryer hookup are conveniently provided on the second floor, as well as ample closet space. The unit has central AC and the heating system is gas forced hot air.

The purchase price is **\$232,972**. Owners are required also to pay property taxes, and the 2019 Sudbury tax rate is \$18.45 per \$1,000 of valuation or an estimated monthly amount of \$469. The condominium fee is estimated at \$164 per month, and the Condominium Association has rules and regulations for all owners that describe the operation of the condominium.

The property is part of the MassHousing affordable housing program, and offered at a discounted rate. As such, this and all future sales of the property will be in accordance with those guidelines and Deed Rider to the unit. These properties will be sold below the market price with deed restrictions which protect the property in perpetuity using resale price limitations.

We invite you to read this information and submit an application, with the supplemental information. This application can be downloaded from the [RHSO website](#) and can be sent to you upon request.

Note: There are currently States of Emergency at the State and Federal levels related to Covid-19. People are encouraged to utilize social distancing and limit contact with people to reduce the potential spread of the virus. In the future, there may

be further restrictions on public social and business activity, including the buying and selling of real estate. Showing this property to lottery winners may be limited, but efforts will be made to show the property virtually. More details about the purchase process will be provided to the winner following the lottery.

Lottery Description:

1. The applications for this housing opportunity will be generally available, including on-line, in hardcopy at the Regional Housing Services Office and the Sudbury Planning Department, and sent to anyone interested in the opportunity. This opportunity will be advertised and communicated through local, regional and state channels.
2. Applications must be received (not postmarked) with all required information by the deadline. Applications can be mailed or dropped off at the address above. Applications that are dropped off should be placed in the big black metal mailbox outside the RHSO office building. Applications may also be emailed, but accompanying documentation should be compiled such that the total submission email/s has no more than 5 attachments, with the applicant consolidating the information. FedEx and UPS deliveries are currently unpredictable since our office is still closed due to the pandemic – regular mail, drop-off, or email are the best submission options. Applicants are encouraged to complete the checklist as an aide to the process.
3. The maximum gross household income will be verified and compared to the HUD 2020 published income limits.
1 person- \$67,400, 2 person- \$77,000, 3 person- \$86,650, 4 person- \$96,250, 5 person- \$103,950, 6 person-\$111,650.
4. The household assets will be verified and compared to the \$75,000 maximum asset limit. Assets include but are not limited to all cash, cash in savings accounts, checking accounts, certificates of deposit, bonds, stocks, cash value of retirement accounts, value of real estate holdings and other capital investments. Equity from the sale of any home will be included with other household assets that cannot exceed a total of \$75,000.
5. Eligible applicants must be a First-time Homebuyer. This is further defined as a household that has not owned a home within three years preceding the application, with the exception of displaced homemaker, single parents and senior households (at least one household member is 55 or over).
A displaced homemaker is an individual who is an adult, who has owned a home only with a spouse, who is legally separated from a spouse, and who does not currently own the home previously owned with a spouse.
Single parents are individuals who owned a home with his or her partner or resided in a home owned by the partner and is a single parent (is unmarried or legally separated from a spouse and either has 1 or more children of whom the individual has custody or joint custody, or is pregnant);
Additional exceptions are made for households that owned a principal residence not permanently affixed to a permanent foundation.
6. Persons must submit all the necessary information by the application deadline. Late applications (applications received after the above date) and applications that are incomplete will not be accepted.
7. All applicants will be screened for eligibility. Applicants who have been deemed ineligible will be notified in writing via email of the decision and given time to contact the resale agent in writing to disagree with the determination.
8. Once the Resale Agent has verified the information contained in the application and confirmed eligibility, a lottery number or numbers and lottery form will be issued, and the applicant will move forward to the lottery.
9. A final lottery eligibility letter will be emailed to each applicant indicating their final eligibility determination and the lottery specifics (date/time).
10. Due to office closures, and in compliance with social distancing guidelines related to Covid-19, the lottery will be conducted via an online meeting using the Zoom online meeting tool. All eligible applicants will be given the information required to join the Zoom meeting if they would like to do so. Lottery tickets will be assigned a number in the sequence in which they are drawn and recorded in the order of selection on the Lottery Drawing Lists. Letters with the lottery results will be emailed within three business days to the winners and all applicants.

11. Once the tickets have been randomly drawn and listed in the drawn order, the units are then ranked based on bedroom size. The top ranked household needing at least the number of bedrooms in the unit will be offered the opportunity to purchase the unit. Note that this is a 2BR unit and no other living spaces can be used as bedrooms. The household size preference shall be given to households based on the following criteria.
 - There is at least one occupant per bedroom.
 - A husband and wife, or those in a similar living arrangement, shall be required to share a bedroom.
 - Other household members may share but shall not be required to share a bedroom.
12. The resale agent shall maintain all Lottery Drawing Lists. Applicants will be given 2 days to agree to purchase the unit before the next person can be offered the opportunity. In the event that any of the applicants withdraw for any reason, or do not comply with the guidelines, the next qualified applicants in the lottery pool ranked by bedroom size need, will be offered the unit.
13. After a buyer has indicated that they want to proceed, the Town, as the monitoring agent, will review the buyer's income, assets and other criteria before the buyer can proceed to purchase the unit.
14. Upon the satisfaction of the qualification requirements of the Monitoring Agent, the qualified buyer is then able to move forward and execute the Purchase and Sale with the seller.
15. All potential buyers are required to attend a First Time Homebuyer Class prior to closing. Organizations offering these classes can be found at www.chapa.org.
16. The State programs and bank products have specific closing and financing requirements. Current mortgage requirements include:
 - The loan must have a fair and fixed interest rate through the full term of the mortgage.
 - FHA Mortgages and family mortgages are not approved for this project.
 - The loan can have no more than 2 points.
 - The buyer must provide a down payment of at least 3%; half must come from the buyer's own funds.
 - Non-household members shall not be permitted as co-signers of the mortgage.
 - The buyer may not pay more than 38% of their monthly income for monthly housing costs.
 - Loans from non-institutional lenders will not be accepted.
17. The Fair Housing Act prohibits discrimination in housing because of Race or color, National origin, Religion, Sex, Familial status. An applicant who believes that they have been discriminated against in the buyer selection and sales process may contact: the Massachusetts Commission Against Discrimination; and/or the United States Department of Housing and Urban Development.
18. Disabled persons are entitled to request reasonable accommodation of rules, policies, or services, or reasonable modification of housing.
19. Resale process: The Monitoring Agent, Town of Sudbury, has up to 90 days after you give notice of your intention to sell the home to close on a sale to an Eligible Purchaser. If you attempt to sell or transfer the home without complying with the Deed Rider requirements, the Monitoring Agents may, among their other rights, void any contract for such sale or the sale itself.

All prospective buyers are advised to review the deed rider with their own attorney to fully understand its provisions.

I/We have been advised that a copy of the Deed Rider is available from the RHSO.

I/We understand that if I/we are selected to purchase a home, I/we must continue to meet all eligibility requirements of the Lottery/Resale Agent and any participating lender(s) until the completion of such purchase. I/We understand that I/we must be qualified and eligible under any and all applicable laws, regulations, guidelines, and any other rules and requirements. I/We understand that the Lottery/Resale Agent makes no representation on the availability or condition of the unit.
