Director's Report June 6, 2023

Overview

<u>Volunteer Appreciation Luncheon:</u> we held our annual appreciation lunch for the library volunteers. As usual, everyone had a great time sharing a meal and socializing with the many community members who freely give their time to the library. We gave them personalized bookmarks engraved with each volunteer's initials, and staff brought in home made desserts. The library could not operate as it does without the help of our volunteers who pull books on request, help out with programs, sort books for the book sale and more.

<u>Pride Day:</u> we will be celebrating our second annual Pride event again with the Sudbury Cooperative Preschool, although this year there are many more community partners, including churches, synagogues, banks and organizations. This year we will be expanding our programming to include teen activities in addition to crafts for little children. The library activities will be held on the front lawn and drag queen and other performances and events will take place on a stage indoors at the church. In the event of rain, all activities will be moved indoors at the church. The event planners have been in close communication with SPD and have a detailed plan in the event of protests.

<u>Teen Study Week:</u> this year the library will not offer extended hours, but will continue to welcome students studying for finals to the library to work. We will provide extra seating, school supplies and candy. We are enlisting parent volunteers to help with student check ins. There will be additional staff in the library to manage the atmosphere and keep things running smoothly.

<u>L-S Senior Service Day:</u> On Wednesday last week, ten high school seniors chose the library for their service day. They helped prepare crafts for summer reading, organized storage spaces, and shifted collections. They did an amazing job and we congratulate them on their graduation!

Statewide news:

The Massachusetts Library System, the Massachusetts Library Association, the Massachusetts School Library Association, and the Massachusetts Board of Library Commissioners have released a joint statement: "Massachusetts Library Organizations Stand with Librarians Against Censorship and Intolerance." It responds to the sharp rise in challenges to books in MA, cites MA General Law, chapter 78, and stands with librarians across the Commonwealth as they face these challenges on the frontlines.

"Book Challenges, Library Collection Policies, and Massachusetts Law" The MBLC will host a webinar on *Thursday*, *June 15 from 10AM-11:30AM*, for municipal leaders to provide an overview of library operations, procedures and statutory requirements led by MBLC Library Advisory Specialist Maura Deedy.

FY24 Budget update: The newly released Senate Ways and Means budget meets the requested amounts in the <u>FY2024 Legislative Agenda</u>. For library funding, budget lines that will be in Conference Committee are:

- State Aid to Public Libraries, line 7000-9501, Senate funded at \$17,600,000 (the legislative ask); House funded at \$16,825,000.
- State Aid to Regional Libraries, line 7000-9401, Senate funded at \$15,967,600 (the legislative ask); House funded at \$15,441,800.

After the conference committee finishes their version of the budget, it will be voted on again by both chambers and sent to Governor Healey to either veto items, or sign into effect. FY2024 starts on July 1, 2024.

1. Endowment

- The Endowment Committee continues to meet to finalize documents and is working on strategies for next steps.
- Next meeting is June 12.

2. Author Series

- Wednesday, June 21, 7pm: A multimedia event and author visit with Jean Duffy, author of Soccer Grannies, and Beka Ntsanwisi, founder of the South African Soccer Grannies team. Soccer Grannies: The South African Women Who Inspire the World tells the story of a team of 40- to 80-year-old women in rural South Africa who defy social convention to play soccer for the companionship and health benefits it provides. Their strength and resiliency help them face life's challenges with dignity, humor, and hope. They teach the rest of us that age, gender, and expectations cannot define an athlete. Jean, a soccer player herself, will recount how their shared love of soccer brought the two teams together on both sides of the Atlantic. Beka will share why she formed the team, the struggles she faces, and her dreams for the future. The event also includes a screening of a short documentary about the Soccer Grannies team.
