- Due to increase in general expenses, automation, increased book/material costs, this current request is slightly more than the typical 2% increase requested.
- Library Employees: Not part of a union like Sudury police, firefighters, DPW, supervisors. Exploration of a potential for market rate adjustment, which has not happened for some time.
- Goal of changing full time vs. part time ratio given high onboarding costs required when there is turnover in staff.
