Call to Order

Nancy Marshall called the public meeting to order at 6:10 pm.

Approval of Minutes

The School Committee voted unanimously to approve the minutes of June 8, June 21 and June 28, 2011 with minor edits.

Lisa spoke about the number of teachers involved in conferences and other programs over the summer, and she herself was at a program at Williams College.

METCO Representative Report

Janine Dailey, our new Shared METCO Director, was introduced to the Committee again. She began officially on August 1st and has already met with parents and was looking forward to meeting the faculty.

Nelson Reyes said that the community was excited about Janine's appointment and he and Mercedes wanted to have a conversation with Janine.

Chairman's Report

Nancy noted that she had met with Jim Rao, Chaiman of the Sudbury Finance Committee to get acquainted and to discuss communication between the Finance Committee and the L-S School Committee. Nancy and Scott had worked on a letter to the Sudbury Finance Committee.

Nancy reviewed the draft list of Subcommittee/Community Liaison assignments with the School Committee and asked Judy to make some minor adjustments.

Nancy confirmed that the School Committee retreat with the Administration will be August 18th from 9:00 to 3:00, tentatively planned at the Lincoln Library. The meeting will be posted. The School Committee calendar was presented and reviewed. The first meeting in September was moved to the second full week of September, with all meetings on the 2nd and 4th weeks of the month. A meeting was added in June based on what has become the norm for meetings in June.

The Town of Sudbury was planning a workshop with legal counsel to discuss open meeting law, executive session protocols, and negotiation sessions and invited the L-S School Committee to participate. The School Committee suggested a 7:00 a.m. meeting as ideal, or a 6:00 p.m. meeting with sufficient notice. Nancy will follow up with Sudbury.

Liaison Reports

New Insurance Regulations: Radha Gargeya reviewed the presentation by EBS Foran in conjunction with the legal firm of Mirick, O'Connell regarding the new regulations and the specific process that must be followed should a community or district choose to adopt the new legislations. There were two meetings held with the towns of Lincoln and Sudbury and L-S on July 18th and August 3rd to compare plans and plan designs and to consider how the new law would impact each Town and the District. Judy commented that the Minuteman Nashoba Health Group was also reviewing the draft regulations and will be exploring the options for the group and the process required.

Superintendent/Principal's Report

Scott explained that the DESE had contacted the District, claiming a communication had been sent to L-S previously, requiring changes to the distict's Anti-Bullying Policy based on the DESE comments. Scott and Sandy Crawford addressed the minor adjustments needed and will bring a copy of the plan to the next meeting with the highlighted changes in order to have a vote on it.

Scott discussed the School Goals and said that he had met with the Administrative Team in June and he would like to spend time at the next School Committee meeting on this. Scott thanked the Committee for encouraging him to attend the M.A.S.S. conference in July. The new insurance regulations were the predominant topic, as well as the new teacher evaluation regulations. CNN correspondent David Gergen was the keynote speaker updating the association on the economy.

Scott took the opportunity at the conference to speak with others about legal costs and advised the Committee that L-S should consider engaging a less costly firm for more routine matters.

Lastly, Scott described the field lighting project that the local sports groups and the Boosters would like to contribute to. Presently the cost is estimated at \$225,000 and the groups are just short of that. Scott supported the project given the very poor condition of the lights and the cost-effectiveness of a new system but expressed concern about the public perception that the school is laying off staff but can afford to install lights. Mark Collins agreed and offered to meet with Scott and the representatives in order to present at the next meeting. Scott explained that he went to court to advocate for the students involved in the Senior prank because, in his opinion, he held the teacher responsible for the situation and the magistrate concurred.

Scott spoke about a young woman who asked him to write a letter of recommendation for her for a private school. It was poignant and reflects the difficulty for students at L-S who need a more hands-on experience and smaller classes. Lisa also wrote a similar letter for a 10th grader. Patty Mostue also commented on two Lincoln students who were not returning to L-S for similar reasons.

July 1, 2011 and to approve a total Assessment of \$23,882,374.20, such amount to be apportioned to the member towns in accordance with the calculation specified in the Regional Agreement.

On a motion by Kevin Matthews, seconded by Radha Gargeya, the School Committee voted unanimously to direct the District Treasurer to certify the apportionment of the above figures in accordance with the Regional Agreement and notify the member towns of their respective shares of such apportionment.

Other Business

Judy reported that the Sudbury Finance Committee had requested further OPEB analysis beyond what the Segal Company had prepared and presented to the School Committee. It appears that the first couple of items that the Finance Committee wants may be simple for Segal to produce but Segal indicated that there may be costs involved in preparing an analysis of the other item. Judy forwarded the information to Segal and is waiting for a specific cost proposal.
