Mr.Kelton emphasized the importance of promoting funding for the METCO program, highlighting its value based on personal experience and contrasting it with misconceptions. School Committee members asked how (they) as a school organization can better support the METCO program, particularly regarding inclusivity.

#### MASC School Committee Self Evaluation

- A school committee member had pointed out that MASC can perform a school committee self-evaluation [for members only] using questionnaires to assess performance on various criteria.
  - A short survey is proposed to gather information on committee performance, benchmarking successes and areas for improvement.

# <u>Proposal to set aside IJOA- Overnight Trip Request- Debate Trip</u> LSRHS Superintendent/Principal Andrew Stephens

- There were four 'Speech and Debate' alternates who became primary members for a University of Kentucky tournament. The upcoming trip request fell within a 30-day approval window mandated by the School Committee policy.
- Mark Terry (Legal Counsel) suggested a vote of approval to waive the policy due to extenuating circumstances.

# Athletic Fees Proposal Discussion

LSRHS Superintendent/Principal Andrew Stephens Daniel Lee, LSRHS Athletic Director

- Swim and Dive and Ice Hockey fees may increase, potentially costing skiers \$800. Currently, all teams pay the same (except ice hockey), but next year outside teams will pay more with the new proposal.
- A \$20 fee increase was proposed within the first 10 years.
- The recommendations from Daniel Lee and Kristeen Patterson were taken into consideration. A shorter review cycle (3-5 years) was suggested to avoid large infrequent increases.
- Regular fee evaluations, early communications to families regarding available financial assistance is also recommended.
- Currently, the system uses next year's fees to pay this year's expenses, which is undesirable.
  - A School Committee member required assurance that the proposed fee increase covers operational costs and unexpected expenses, rather than building a surplus. The School Committee discussed unexpected athletic department costs, including field and court maintenance, and the need for a financial "buffer" to cover the expenses, as well as other unforeseen expenses, such as ski trip costs.
- A phased-in fee increase is deemed administratively complex and impractical, so a single, larger increase is preferred.
- Better cost estimates are expected by summer and fall, with communication to families planned for August.
- The full School Committee agreed to review these fees within three years.
