# <u>Tri-District School Committee Meeting</u> Ravi Simon, *Chair of the LSSC*

- A productive 'Tri-District School Committee' meeting (Lincoln, Sudbury, and LSRHS) discussed the school calendar factors.
- The School Committees aimed to synchronize calendar approval processes and reviewed sample policies from Wellesley and Brookline.
- A subcommittee will be organized to make recommendations regarding the school calendar.

- The 'Relay for Life' club is hosting an event at Peter Noyes Elementary school on Tuesday, June 17th to raise money for cancer research, and cancer related causes.
- The 'End-of-Year Celebration' will take place on Wednesday, June 11th at Pierce House at 2:15PM. School Committee members are welcomed to attend and potentially speak.
  - There are seven (7) LS staff retiring at the end of the 24-25 school year;
     these individuals will be celebrated for their contributions to LSRHS.
