LSSC-LS Teachers Association Contract Negotiations Announcement Kevin Matthews. Chair of Negotiations Subcommittee

■ The L-S School Committee approved the L-S Teachers

- The L-S School Committee approved the L-S Teachers' Association contract for 2025-2028. The School Committee's negotiating committee members appreciated the collaborative process, the work, and dedication of the TA negotiators.
- The contract includes:
 - 7.375% COLA (cost of living adjustment) in Schedule A, with 3% in the first year, 3% in the second year, 1.375% in the third year.
 - Completely re-working Schedule B (stipends) with a formula to ensure a more consistent approach to compensation for the important work of coaching and clubs/activities
 - Changes to paid time off policies, including allowing educators to use bereavement days for the loss of an uncle or aunt, requiring approval for the use of more than 2 consecutive personal days or personal days which abuts school vacation, holiday, or leave, and a provision allowing the Admin to discuss excessive absences with teachers and factor that into their evaluations.
 - Other smaller technical changes intended to clarify portions of the contract or address minor concerns brought up by the Teacher's Association or School Committee, or LS administration.
