### **Site Observations:**

- F&O visited the project site and walked the length of the project.
- The following observations were made:

## Between Sta 101+00 and 116+00 (Project start to Codjer Lane)

- The pervious paver and concrete portion of the rest area at the project beginning has been completed. (See Photo 1)
- Proposed plantings have either been planted or are staged near the planting locations. (See Photo 2)

#### Between Sta 116+00 and 143+00 (Codjer Lane to Old Lancaster Road)

• Proposed plantings have either been planted or are staged near the planting locations. (See Photo 3)

#### Between Sta 143+00 and 175+00 (Old Lancaster Road to Hudson Road)

- Proposed plantings have either been planted or are staged near the planting locations.
- Drainage work has begun at Hudson Road including:
  - o Installation of both 12-inch reinforced concrete pipes and flared ends. (See Photo 4)
  - o Installation of one proposed catch basin. (See Photo 5)
- Electrical work has begun at Hudson Road including:
  - o Installation of conduit beneath Hudson Road and Peakham Road. (See Photo 6)
  - o Preparation of the conduit for the traffic signal controller. (See Photo 7)
  - o Installation of all proposed pull boxes.
- It appears that the 1-inch polyethylene water line had been installed based on the location of a patched trench.
- All signal post foundations have been constructed. (See Photo 8)
- The island on Peakham Road has been removed and patched. (See Photo 9)



#### Between Sta. 175+00 and 215+80 (Hudson Road to Morse Road)

- Proposed plantings have either been planted or are staged near the planting locations. (See Photo 10)
- The proposed pull box on the north side of Hudson Road has been installed. (See Photo 11)

## Between Sta. 215+80 and 275+00 (Morse Road to Haynes Road)

- Proposed plantings have either been planted or are staged near the planting locations.
- The pervious paver and concrete portion of the rest area north of Morse Road has been completed. (See Photo 12)
- The proposed rest area at the parking lot is nearly complete. (See Photos 13-15)
- The pervious paver rest areas have been constructed. (See Photo 16)
- Some interpretive signs have been installed in their proposed locations. (See Photo 17, also seen in Photo 16)

#### Between Sta. 275+00 and 284+50 (Haynes Road to Pantry Road)

• Proposed plantings have either been planted or are staged near the planting locations. (See Photo 18)

#### Between Sta. 284+50 and 335+50 (Pantry Road to Project End)

- Proposed plantings have either been planted or are staged near the planting locations.
- The rest area south of North Road has been constructed. (See Photo 19)
- A concrete pipe has been installed to replace the metal pipe at Sta. 332+50 and the side slope grading was being worked on during the visit. (See Photo 20)
