## **Chiswick Park Expansion Presentation**

Ted Pasquarello presented a conceptual plan for expansion of Chiswick Park on Boston Post Road.

He presented first an overview of the current site conditions. He also gave some history of the business park. He began purchasing land and buildings in that area of town in 1980 and has added parcels as they have become available. Recently he purchased the lot known as 460 Boston Post Road (about 5 acres). The proposed plan is to build a 20,000 sq. ft building (two stories) with an 80 car parking lot on part of his current holdings. This would be office not warehouse space. He would then donate 4.8 acres of his newest purchase to the town for open space/park land. No additional entrances would be needed onto Boston Post Road or Union Avenue. The plan would include a walking trail within the business park that would connect to Rte 20 and Union Avenue.

He has presented this idea to the Conservation Commission and the Selectmen and both have encouraged him to develop detailed plans. He has also met with the Building Inspector, Fire Chief and Town Planner.

The Planning Board also encouraged him to begin the process and looks forward to seeing a detailed plan soon.
