## I. <u>School Committee Report</u>

#### A. Bill Schedule

## II. Superintendent's Report

#### A. Recognition

The Superintendent recognized Nixon teachers Melissa Morabito and Amie Abdal-Khabir for receipt of the Sudbury Special Needs Advisory Council's 2003 Teacher Appreciation Award. The Superintendent recognized, on behalf of Dr. Jessica Rubenstein, Nixon 4th Grade Teachers for a successful Odyssey trip. Patti Grenier spoke about the positive changes made to the trip.

Bill Braun recognized Bill Hurley, Patti Grenier, and Paul Funk for their years of service.

# B. Comprehensive Literacy Program

Patti Grenier presented the Sudbury Comprehensive Literacy Program document which is a culmination of two years' of effort. Professional Development opportunities will be available next year which will focus on the individual areas of the Program.

## C. Instrumental Music Lesson

Patti Grenier reported on the status of the Instrumental Music Program. Last year Instrumental Music Teachers were cut back and service delivery was consolidated and offered one year later. An after school program was begun and was successful. However, the structure of communicating information and collecting money was inefficient. Patti recommended continuing the after school program but raise fees to include administrative support.

## D. Title I Entitlements for FY '04

Patti Grenier reported that Sudbury is eligible to receive \$123,958 in Title I funds. The funds must be spent in schools with the two highest percentages of students receiving free and reduced lunch (Loring and Curtis).

## E. Contract Update

The Superintendent reported that the contract negotiations with the Nurses' Association have been agreed to. He announced the only change to their contract was a one year agreement on compensation, with some changes to the salary grid.

**VOTED**: On a motion by Alexa Crowe, seconded by Bill Braun, to accept the contract for the Nurses' Association. The vote was 3-0 in favor.

## F. Selection of Assistant Superintendent

The Superintendent, on behalf of Superintendent-elect John Brackett, recommended Robert Milley as Assistant Superintendent.

**VOTED**: On a motion by Alexa Crowe, seconded by Susan Iuliano, to accept the appointment of Robert Milley as Assistant Superintendent. The vote was 3-0 in favor.
