II. Superintendent's Report

A. Recognition

The Superintendent recognized Curtis Middle School student, Warren Porter, won recently won, for the send year in a row, the Curtis Spelling Bee, and has qualified for the State finals.

B. New Middle School Extracurricular Activities

The Superintendent recommended a proposal to add Cross Country, Spring Track and School Newspaper as additional after school activities for the 2003-2004 school year. Dr. Kevin Plodzik and Tom Lopez were in attendance to explain how these additional activities would be funded.

VOTED: On a motion by Karen Krone, seconded by Bill Braun, to add Cross Country, Spring Track and School Newspaper activities to the Middle School, contingent upon successful negotiations with the SEA and provided it is within the parameters of the budget. The vote was 5-0 in favor.

C. Budget Update

The Superintendent explained that the potential impact of the Governor's budget would result in the need for an additional \$400,000 reduction to the Town (approximately \$200,000 could be the Schools' share) in addition to the reductions necessary in the Finance Committee's budget (approximately \$250,000 for the Schools). This would result in about a \$450,000 reduction necessary before any negotiations settlement and decisions regarding the Circuit Breaker

funds. The Superintendent presented several scenarios from the Administrative Leadership Team for reductions. The Committee discussed these scenarios in detail.

D. Administrative Search Updates

The Superintendent updated the Committee on the following searches:

- Middle School Principal Three finalists have been identified and site visits are being conducted.
- Business Manager 6 people have been interviewed and two strong candidates have been identified.
- Assistant Superintendent This position has been advertised and resumes are being received.

E. 2003-2004 School Calendar

Patti Grenier presented a School Calendar for 2003-2004.

VOTED: On a motion by Karen Krone, seconded by Kathy Precourt, to accept the calendar as presented with a starting date for teachers of September 2 and a starting date for students of September 3. The vote was 5-0 in favor.
