B. MCAS Report, ELA and Math

Jan Binus, ELA Curriculum Specialist, and Sarah Guernsey, Math Curriculum Specialist, were present to review the 2003 MCAS results. They highlighted areas of concern and recommendations for next steps.

C. 2004-2005 School Calendar

The Superintendent presented two versions of the 2004-2005 School Calendar, one with a pre-Labor Day start and one with a post-Labor Day start. Lincoln-Sudbury will be starting after Labor Day. This item will be put on the agenda for the next meeting.

D. 2005 Enrollment

The Superintendent presented enrollment projections of 3,133 for the 2004-2005 school year. The Superintendent also reported that the current enrollment is 3058 as of November, 2003.

E. Budget Projections

Mary Will presented an initial projection for the FY 2005 Budget. The Superintendent reported on recent action by the State on Circuit Breaker Funding. The net result was a positive one for Sudbury in terms of funding received vs. amount budgeted, however based on the original funding formula of 75%, Sudbury is still underfunded by over \$400,000.
