# I. School Committee Report

## A. Bill Schedule

## II. Superintendent's Report

### Recognition

The Superintendent recognized Eddie Good, Curtis Teacher, who has been inducted into the National Honor Roll of Outstanding American Teachers.

## A. Elementary Student Activity Account Limit Increase

Mary Will explained that the current limit of \$5,000 is insufficient to accommodate the funds necessary for the 4<sup>th</sup> grade Odyssey trip and recommended increasing the limit to \$10,000. This is the first of two necessary votes to change the existing policy.

**VOTED:** On a motion by Susan Iuliano, seconded by Jeff Beeler, to increase the limit of the Elementary Schools - Student Activity Checking Account limit from \$5,000 to \$10,000. The vote was 5-0 in favor.

#### B. Havnes School Grant Account

Mary Will explained that a new account is necessary for the \$5,000 Math Enrichment Grant recently received from the Sallie Mae Fund for the Haynes School.

**VOTED:** On a motion by Rich Robison, seconded by Bill Braun, to establish a grant account in the amount of \$5,000 for the Haynes Math Enrichment Grant. The vote was 5-0 in favor.

## C. Facility Usage Update

Mary Will updated the Committee on the Facility Usage Policy. The Policy has been very workable to date. She commented on the positive working relationship with Barbara Cole, Director of Sudbury Extended Day.

# D. FY '08 Budget

Dr. Brackett reported on recent meetings with the Town Budget group regarding the current budget picture. The group discussed a proposed override for a level staff budget. A non-override budget would require over \$1 million in cuts. On March 19 at 7:30 p.m. the League of Women Voters will moderate the Town's Budget Forum.

Debbie Dixson gave an overview of special education programs available in the K-8 system, focusing on adding programs to provide a continuum of services with the goal of educating students within the district whenever possible.
