4. Loring PTO (Welcome)

Cara Maxwell and Susan Smith, PTO Co-Chairs, welcomed the Committee to Loring School and highlighted the PTO efforts to purchase Active Boards for all 3rd, 4th, and 5th grades. They questioned whether the level of fundraising at the various schools in recent years necessitates some guidelines around equity among schools. They also requested information regarding using PTO funds for items that may or may not be included in future budgets.

5. Loring State of the School ReportClifton LaPorte, Loring Principal, presented the ÒState of the SchoolÓ report, highlighting efforts to develop school culture, continue to use assessment data to inform instruction, and continue efforts to support students and staff through the FOCUS process. The vote was 5-0 in favor. 6.
