3. Peter Noyes PTO (Welcome)

Asha May and Trish Griffin, PTO Co-Chairs, spoke briefly about the Noyes PTO funding efforts.

4. Noyes State of the School ReportAnnette Doyle, Noyes Principal, and Kristen Moffatt, Noyes Assistant Principal, presented the Noyes OState of the SchoolÓ Report.
