# Sudbury Public Schools (SPS) School Committee Meeting Minutes March 8, 2017 @ 6:45 PM @ Sudbury Senior Center

#### **Open Session**

**Chair Lucie St. George** opened the session at 7:03 PM. Sudbury Cable TV is broadcasting live.

#### I. Legislative Forum

- A. Chair Lucie St. George welcomed State Representative Carmine Gentile and Senators Michael Barrett and James Eldridge to the meeting. In introductory remarks, topics discussed included local aid, the Legislators' Committee assignments, and the Income Tax for Education and Transportation Amendment ("Millionaire's Tax") ballot initiative that will be voted upon statewide in 2018.
- B. The first set of questions for the Legislators centered on public school funding, particularly special education funding and unfunded mandates. The reasons behind, strategies for managing, and budgetary effects of increasing healthcare costs were also discussed.
- C. The Committee and the Legislators also discussed the topic of school start times. Representative Gentile noted that he filed legislation to have the issue studied by DESE for the State House of Representatives. The complications of later start times, including increased busing costs and the corresponding start time of afterschool sports, were discussed.
- D. The lack of competition in contract bidding for school busing services was discussed. The Committee and the Legislators considered the possibility of adjusting laws to allow towns to charge a fee to all families for bus service, regardless of the distance of the family's home from the student's school.
- E. The Legislators discussed their positions on, and actions taken in support of, the Commonwealth's immigrant and LGBTQ communities.
- F. The Committee took a 10 minute break at 8:05 PM.

G. The Committee returned from its break at 8:16 PM.

The specific assessments used in English Language Arts, Mathematics, and Social Emotional Learning were explored.

- B. The Committee agreed to investigate the possibility of holding a joint meeting with the School Committee for Lincoln-Sudbury Regional High School, to discuss the progress of each district on the subject of school start times and next steps.

A. Assistant Superintendent Kim Swain informed the Committee that Ed Eich and Holly Estes were awarded a SERF grant in the amount of \$2,467 for the program "Headstarting Frogs". Dorothy Kramer from Haynes Elementary School was awarded \$9,951 to support the STEAM pilot program. Barbara Gogan and Elizabeth Clark were awarded a SERF grant for \$3,755 to connect SEL learning and literature. Ms. Swain presented the Teaching and Learning Curriculum newsletter to the Committee, which contains a survey for the community about mathematical learning in Sudbury. The survey was sent out electronically the previous week, and will be emailed out again soon.
